Transfers are free of charge and will be honored on a first come, first serve basis.

Municipality or Non-Profit Organization: Use the Surplus Request Form found under Related Links. When you complete the Surplus Request Form, you may mail or fax the form to the Surplus Property Office for processing. Please be sure to enclose proof of non-tax status.
