DECISION

CHANCHETHA CORPORATION DBA THE WINE NOOK
18 MAIN STREET
TOWNSEND, MA 01469
LICENSE#: 128600010

Chanchetha Corporation dba The Wine Nook (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, July 9, 2013, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an Illegality on the licensed premises, to wit: c. 138 §34 Sale or Delivery of an Alcoholic Beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Doyle's Report.

The following documents are in evidence:

1. Licensee's Stipulation of Facts; and
2. Investigator Doyle's Compliance Check Field Report dated February 26, 2013.

FACTS


1. On Tuesday, February 26, 2013, at approximately 6:50 p.m., Investigators Bailey and Doyle conducted an investigation of the business operation of Chanchetha Corporation dba The Wine Nook.
2. An underage operative working with investigators purchased an alcoholic beverage, a container of Bud Light beer, for two dollars and thirty cents (\$2.30). The underage operative was not asked for identification.

CONCLUSION


Based on the evidence, the Commission finds the licensee violated 204 CMR 2.05 (2) Permitting an Illegality on the licensed premises, to wit: c. 138 §34 Sale or Delivery of an Alcoholic Beverage to a person under twenty-one (21) years of age. Therefore, the Commission **suspends the license for three (3) days of which three (3) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.**
