An Initiative Petition for The Massachusetts Family Sunshine Protection Act

Be It Enacted by the People, and by their authority:

Section 1. (1) This act may be cited as the “Family Sunshine Protection Act.”

(2) Notwithstanding how time is advanced pursuant to 15 U.S.C. s. 260(a), and notwithstanding G.L. c. 4, § 10, or any other general or special law to the contrary, daylight saving time shall be the year-round standard time of the entire state and all of its political subdivisions.

(3) Each district school board may adjust school start times based on student safety and available daylight as a result of this section.

(4) The Department of Agriculture Resources and Office of Consumer Affairs and Business Regulation may study adjustments in standard agricultural practices as a result of this act.

Section 2. This act shall take effect January 1, 2015.
