Attorney General Martha Coakley, State Police Internet Crimes Task Force, and Local Law Enforcement Partners Announce Charges Against the Following Seven Individuals in Connection with a Major Cyber Crime Sweep Targeting Users of Child Porn:

Kevin Moore, age 33, Weymouth:

Charges:

- Possession of Child Pornography
- Distribution of Obscene Material

Moore was arrested on October 24, 2010. He will be summonsed for arraignment in Quincy District Court.

Stephen Haddad, age 23, Weymouth:

Charges:

- Possession of Child Pornography
- Distribution of Obscene Material

Haddad was arrested in Weymouth on October 24, 2010, and arraigned the next day in Quincy District Court. He pled not guilty and was released on \$1,500 bail. Haddad is due back in court on November 24, 2010.

Barry Bushway, age 47, Peabody:

Charges:

- Distribution of Obscene Material
- Possession of Child Pornography

Bushway was arrested in Peabody and subsequently arraigned in Peabody District Court on October 26, 2010. At arraignment he pled not guilty. Bail was set at \$5,000. Bushway is due back in court on December 10, 2010.

Fred Papa, age 67, East Falmouth:

Charges:

- Distribution of Obscene Material
- Possession of Child Pornography

Papa was arrested in East Falmouth and subsequently arraigned in Falmouth District Court on October 26, 2010. He pled not guilty and was released on \$2,500 bail. His next court date is December 17, 2010.

William McDonagh, age 51, Hull:

Charges:

- Possession of Child Pornography

McDonagh was arrested in Hull and arraigned in Hingham District Court on October 25, 2010. He pled not guilty and was released on \$1,500 bail. McDonagh is due back in court on November 5, 2010.

Michael Kelliher, age 48, Marshfield:

Charges:

- Distribution of Obscene Material
- Possession of Child Pornography

Kelliher was arrested in Marshfield and arraigned in Plymouth District Court on October 25, 2010. He pled not guilty and was released on \$2,500 bail. Kelliher is due back in court on December 8, 2010.

Michael Amato, age 36, Berlin:

Charges:

- Possession of Child Pornography

Amato was arrested in Berlin and arraigned in Clinton District Court on October 25, 2010. He pled not guilty and was released on \$500 bail. Amato is due back in court on November 23, 2010.
