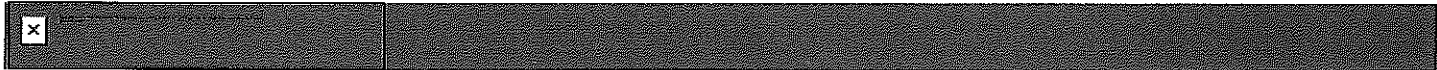

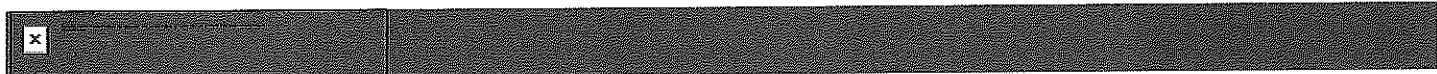

Describe the regulatory issue or observation::	These regulations were adopted in response to M.G.L.c. 82A, section 1 (Trench Safety). While the regulations comply with the MGL, they do not improve public safety where unattended trenches are concerned. The requirement that a trench permit be obtained adds cost to any project because the excavator must obtain a permit, and the community must issue it. If an unsafe, unattended trench is found, the permit only allows us to track down the person who may have obtained the permit (as opposed to someone who didn't).
Suggestions for improvements to the regulation::	The MGL must be amended to eliminate the need for the permit, while providing better enforcement tools for safety. The legislature failed to heed the comments of field staff who provided better opportunities for safety with less cost and oversight.

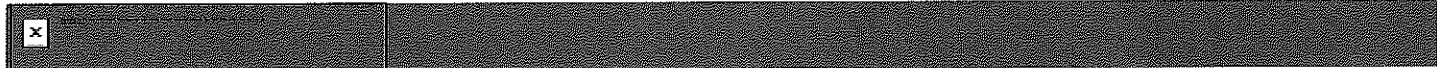
