Commonwealth Facility Fund for Energy Efficiency (CoFFEE) Signature Page

I understand and acknowledge that if DCAMM approves a disbursement of the requested funds from the CoFFEE Fund for the Project described in this application: (1) the execution of an Interdepartmental Services Agreement (ISA) will be necessary for the Agency to receive the approved amount; (2) additional documents may need to be executed and processed in order to arrange for the repayment of CoFFEE funds to DCAMM (as manager of the CoFFEE Fund) for the Project; (3) DCAMM may require, as a condition of the Agency's receipt of the CoFFEE funds, that DCAMM receive rebates and/or other incentives provided by utility companies for the Project as repayment for some or all of the CoFFEE funds granted to the Agency; and (4) DCAMM shall not be responsible for providing the Agency with funds in any amount greater than the approved disbursement of CoFFEE funds, regardless of whether the Agency requested a higher amount in this application or of any increase in Project costs.

I represent that I am duly authorized to enter into agreements on behalf of the Agency that provide for the receipt, commitment, and payment of funds from the Agency. I agree to cooperate fully with DCAMM and any other state agencies or entities (including without limitation the Office of the Comptroller) in executing an ISA and any and all other documents necessary to effect the transfer of CoFFEE Funds to the Agency and repayment of such funds by the Agency to DCAMM.

I understand that the Agency is solely responsible for ensuring that the Project complies with all applicable laws and regulations, including, without limitation, those governing procurement and the disposal of hazardous material. Without limiting the foregoing, I acknowledge that, in the event that the Project is not being procured by the Agency pursuant to and in accordance with M.G.L. c. 25A s. 14, the Agency must obtain a delegation from DCAMM in order to proceed with the Project in accordance with M.G.L. c. 25A s. 11, regardless of whether the Project receives funding from DCAMM from the CoFFEE Fund or any other source. I understand and agree that no communication from DCAMM, including, without limitation, an approval of this CoFFEE Fund application, constitutes a delegation pursuant to M.G.L. c. 25A s. 11 unless it is made in writing, expressly indicates that the communication is intended to effect a delegation, and is signed by the Commissioner of DCAMM.
