YOU WILL NOT BE ALLOWED TO SIT IN SPRINGFIELD.**

All applicants not assigned to Springfield must take the examination in Boston. Once assigned to Springfield, seating cannot be changed to Boston. **PLEASE MAKE SURE YOU NEED TO SIT IN SPRINGFIELD, AS YOU MAY BE TAKING A SEAT FROM AN APPLICANT WHO DOES NEED TO SIT IN SPRINGFIELD.**
