

Coyne Lyons Poole	Michael Thornton was one of only 15 U.S. Navy personnel who received the Medal of Honor (1973) for their heroic actions during the Vietnam War. On his last tour to Vietnam, at the age of 23, Thornton heroically saved the life of his senior officer on an intelligence gathering and prisoner capture operation. Thornton ran into a hail of enemy fire to retrieve the officer's body, and found him badly wounded and unconscious, but alive. He dragged him to the beach, inflated his life vest, and swam, towing both the officer and a wounded South Vietnamese commando seaward for two hours before they were rescued by a comrade in a support craft. 
