ONLY NON-DISPOSITIVE MOTIONS MAY BE MARKED FOR HEARING BY A PARTY. DISPOSITIVE MOTIONS UNDER MASS. R. CIV. P. 12 (b) (1), 12 (b) (6), 12 (c) AND 56 WILL BE SCHEDULED BY THE COURT IN ALL CASES, REGARDLESS OF WHEN COMMENCED.

MOTIONS IN ALL TAX LIEN CASES, REGARDLESS OF WHEN COMMENCED, MAY BE MARKED FOR HEARING ANY **THURSDAY AT 10:00 A.M. OR 2:00 P.M.**
