On Monday, May 16, 2016, this officer, Trooper Christian T. Paluk, ID 3043, was monitoring traffic in the vicinity of Kelley Square when a vehicle passed my location and traveled up Vernon Street and took an immediate left turn onto the eastbound on-ramp to RT290. A subsequent check of the vehicle's registration showed that the MA plates (4PJX80) belonged on a Nissan Maxima, not a Acura Infiniti. Vernon Street is a public way in the Commonwealth of Massachusetts. This officer activated the emergency lights in a fully marked cruiser, #1146, and effected a motor vehicle stop without incident. The registry check also showed that the owner/operator, ZAMBRANO, Jorge A., DOB 03/14/81 was also operating the vehicle with a revoked license. ZAMBRANO was then placed under arrest at the scene without incident. Cuffs were double-locked.

Trooper Moran, CR1834, arrived on scene to assist.

ZAMBRANO was charged with: Chapter 90 Section 23 - Attached Plates, Chapter 90 Section 23 - Revoked License, and Chapter 90 Section 9 - Expired Registration. The vehicle was towed away from the scene by Boulevard Towing.


