I then approached a third male of Hispanic race who was later identified as Jorge Zambrano 03/14/84. Zambrano appeared to be nervous, breathing heavily and began to place both his hands in his pockets. As I approached him he began to slowly back away. Zambrano was dressed in cream khakis, black shoes and a yellow button down shirt which was messily half un-tucked in the front yet tucked in on his back. Due to the violent nature of the call and the retrieving of both a butcher knife from Simpson and a secondary folding knife from Giangregorio, I instructed Zambrano to place his hands on the rear of the Cadillac. He complied at first but continued to remove his hands from the vehicle despite numerous requests to remain still. For fear of the safety of myself and others, I then began to perform a pat frisk for any possible weapons. Upon attempting to pat frisk Zambranos groin area, he began to move his feet closer together. I then felt a large bulge, and immediately Zambrano began to close his legs and attempted to step away from me as if he was concealing a possible weapon.


Zambrano then violently turned towards me and struck me in the right hand side of my jaw with a closed fist. A violent struggle ensued and P.O. Hanlon observing my struggle attempted to assist me in controlling Zambrano who was yelling and screaming obscenities disturbing the nearby neighbors who were beginning to exit their households. As we attempted to handcuff Zambrano we slipped on the ice and fell to the ground as he violently kicked and punched both P.O. Hanlon and myself. As the struggle continued Zambrano was able to stand up and dove head first into the open passenger side window of the Cadillac. P.O. Hanlon and I attempted to regain control of Zambrano who was now half in the passenger side window and kicking us. I was positioned on the right hand side of Zambrano and observed him ripping open the center console of the Cadillac. He then retrieved what appeared to be a closed wooden handled knife. I then was able to reach into the vehicle and grab Zambrano's hand, which was wrapped around the knife. I then pinned the knife between my hand and his waste to keep him from opening it and stabbing both P.O. Hanlon and myself. We then dragged Zambrano out of the Cadillac, slipping yet again on the ice. Upon falling to the ground, the knife was dislodged from his grasp and came to rest by the rear tire of the vehicle. Zambrano then violently kicked P.O. Hanlon and was able to get back up, free himself, and flee down Fairbanks St towards Ames St. I then pursued on foot with P.O. Hanlon following and was able to take Zambrano to the ground; he was able to free himself as we slipped on the ice again. Zambrano then reversed his direction and fled towards the running Cadillac again.



at which time P.O. Hanlon and P.O. Steve Donnellan were able to take him to the ground and handcuff him after another brief struggle.

Search incident to arrest I performed a pat frisk of Zambrano prior to his transportation in the patrol wagon. At this time I again felt an odd bulge in Zambranos groin area. Believing that the bulge may be illegal narcotics I then retrieved it and observed a clear plastic baggie containing several more individually wrapped plastic baggies which contained an off-white substance that I believed through my training and experience to be both powdered cocaine and crack cocaine packaged for sale. These narcotics were confiscated and a later weighing of the narcotics in Worcester Police Dept. service division revealed a weight of 37.1 grams.

The Court has therefore ORDERED that the defendant be committed to the above institution in lieu of posting the bail indicated above, and there await his or her next court appearance at the court location of next event indicated above.

Any duly authorized officer is hereby ORDERED to convey and deliver the defendant safely to such institution, and to make return thereon. The official in charge of such institution is hereby ORDERED to receive the defendant into custody, to keep the defendant safely, and to return the defendant to the court indicated above on the date and time of next event indicated above, unless the defendant earlier posts bail as ordered, or is otherwise legally discharged before such date.
