FINDING OF JUDGE -- DETERMINATION OF INDIGENCY

After considering the report and recommendation of the probation officer or other appropriate court employee, and after interrogating the defendant named in the complaint on the reverse side, if appropriate, based upon the standards in Supreme Judicial Court Rule 3:10, I FIND THAT THE DEFENDANT IS:

- INDIGENT** because the defendant:
 - receives Aid to Families with Dependent Children (AFDC).
 - receives Emergency Aid to Elderly, Disabled and Children (EAEDC).
 - receives poverty-related veterans' benefits.
 - receives food stamps.
 - receives refugee resettlement benefits.

 - receives Supplemental Security Income (SSI).
 - is a patient in a mental health facility or treatment center (or is the subject of a proceeding for admission to such a facility) and lacks available funds.

 - has an annual income, after taxes, 125% or less of the current poverty threshold referred to in G.L. c. 261, § 27A(b).

the process of registering it. He indicated that the registration plate on the M/V belonged to his mothers M/V which is parked in front of 3 Euclid Ave and he put the plate on the M/V this morning so he could drive it to work. I asked Mr. Zambrano if he had been to the Registry of M/V's or to an insurance company regarding this M/V and he stated no.

I did a Registry of M/V's computer check on Mr. Zambrano's Learners Permit. The response indicated an active Learners Permit. I did a Florida RMV computer check on Florida Registration PMA1ST. The response indicated no matching record found. I did a Florida RMV computer check on VIN JHMB413XMC010639. The response indicated expired registration, date of expiration was 12/15/99. The listed owner of the M/V was Humberto Zambrano of 8802 S.W. 150TH Place Circle, Miami Florida. The M/V is listed as a blue 1991 Honda, 2 door.

I approached the M/V and told Mr. Zambrano to exit the M/V which he did. I told him that he has to have a licensed driver seated next to him when he drives. He indicated that he knew that. He was placed under arrest, handcuffed and transported to the station via patrol wagon. The M/V was towed to and by Pat's Towing at the operators request. A tow inventory form was completed. The Florida registration plate was seized and held for court presentation.

Citation #H 5412986 was issued to Jorge Arturo Zambrano for 1) One Way violation, 2) Unlicensed Operation of a M/V and 3) Illegally Attaching Plates. Citation #H 5412987 was issued to him for 1) Operating Unregistered M/V and 2) Operating Uninsured M/V.
