

1. On Tuesday, 08/12/2014, at approximately 2145 hours, I, Trooper Alena Sullivan #3883, observed a motor vehicle bearing MA reg: 34SX66 make a turn from Blackstone River Road onto Millbury Avenue, both public ways, at what I estimated to be excessive rate of speed. The vehicle turned so fast that it crossed the white fog line and traveled onto the breakdown lane. I activated cruiser emergency lights to conduct a motor vehicle stop. The vehicle pulled over.

2. I approached the vehicle and asked the operator (later identified as Jorge Zambrano) for his license and registration. He provided me with the registration and stated that he only had a Massachusetts ID card. I checked with station C regarding ZAMBRANO and was able to confirm that his license to operate a motor vehicle had been suspended.

3. I asked ZAMBRANO to step out of the vehicle, handcuffed him (double-locked), pat frisked him, and placed him in the back of my cruiser. A licensed operator took control of the vehicle.

4. I transported ZAMBRANO to MSP Station C2 in Millbury for routine booking and fingerprinting procedure. ZAMBRANO was read his Miranda rights and was allowed to make a phone call. He was issued a Massachusetts Uniform Citation R4380070 for:
