

MIDDLESEX COUNTY SUPERIOR COURT – Located in WOBURN as of March 17, 2008

200 TradeCenter, Woburn, Mass. 01801

Located in the TradeCenter on Sylvan Road; Accessible to the mobility impaired.

For electronic mapping software, use 200 Sylvan Rd., Woburn

Free surface parking around the Courthouse.

From West and Central: Take Mass. Pike (I-90) or Route 2 East to Route 128 (I-95) North. Take Exit 34 (Winn St.) off Rte. 128. At bottom of the exit ramp turn left on Winn St. Travel 0.2 miles and turn right on Beacon St. (just after exit ramp from 128 South). Follow Beacon St., which becomes Sylvan Rd., for 0.8 miles, turn left into the TradeCenter and follow signs to Superior Court.

From North: Take I-93 South to Route 128 (I-95) South. Travel 1.6 miles to Exit 35 (Rt. 38/Main St.) Stay right off exit ramp and take first right (Route 38 North). Turn left at first stoplight onto Elm St. (0.1 miles). Turn left onto Sylvan Rd. and proceed 0.3 miles past shopping plaza, then turn right into the TradeCenter and follow signs to Superior Court.

From Boston: Take I-93 North to Route 128 (I-95) South. Travel 1.6 miles to Exit 35 (Rt. 38/Main St.) Stay right off exit ramp and take first right (Route 38 North). Turn left at first stoplight onto Elm St. (0.1 miles). Turn left onto Sylvan Rd. and proceed 0.3 miles past shopping plaza, then turn right into the TradeCenter and follow signs to Superior Court.

From Edward J. Sullivan Courthouse/Cambridge District Court: Exit the parking garage just east of the courthouse, turn right onto Thorndike St (one way) and then left onto First St. Follow First St. to end and turn left onto Cambridge St. At second set of lights turn right onto Third St. Follow Third St to end and turn left onto McGrath Hwy. (Rt. 28 North). Follow McGrath Hwy to I-93 North and follow directions from Boston above.

From Woburn District Court, 30 Pleasant St.: Exit the rear of the parking lot across from the courthouse onto Harrison Ave. At the end of Harrison Ave. turn left onto Winn St. Follow Winn St. for approximately 1.5 miles under Rt. 128/95 overpass and turn right onto Beacon St. just after highway off ramp. Follow Beacon St. (which becomes Sylvan Rd.) for 0.8 miles and turn left into the TradeCenter. Follow signs to Superior Court

Public Transportation: Bus Route 134 provides regular service to the TradeCenter via Wellington Station (Orange Line) and Winchester Center (via Lowell Commuter Rail).
