

PUTNAM CLUB EAST, ENTRANCE E1

FROM THE NORTH: Take Interstate 95 South to Exit 9 onto Route 1 South. Merge onto Route 1 South and follow for approximately 3 miles until you see Gillette Stadium at Patriot Place on your left. Once you reach the Stadium, go through one set of lights and at the second set take a left onto P6 Drive. Bear right at the intersection, and then take your first left turn after the Renaissance Hotel. The Stadium will be in front of you. The W3 EMC Suite and W4 Putnam Club entrances are on your right. Lighted electronic boards and directional signs will direct you to your event.

COMING FROM THE SOUTH: Take Interstate 95 North to Interstate 495 North: Exit 14A onto Route 1 North. Follow Route 1 North approximately 4 miles to Gillette Stadium at Patriot Place (on the right). Once you reach Patriot Place, go straight through the lights at Bass Pro Drive and then take the P8 entrance on your right. This road will lead you to the west stadium parking lots. The W3 EMC Suite and W4 Putnam Club entrances are on your right. Lighted electronic boards and directional signs will direct you to your event.
