**63 People Arrested in Plymouth and Norfolk Counties
for Oxycodone Related Drug Offenses**

BROCKTON, MA- Plymouth County District Attorney Timothy J. Cruz and Norfolk County District Attorney Michael W. Morrissey today announced the arrest of 63 people in Plymouth County and Norfolk County for oxycodone (Percocet) related drug offenses.

In July of 2011, the State Police Detectives Units assigned to the Plymouth County District Attorney's Office and the Norfolk County District Attorney's Office, along with the State Police Diversion Unit, the Norwell Police Department and the Drug Enforcement Administration Diversion Unit conducted an investigation into the use of false prescriptions to fraudulently obtain oxycodone from various pharmacies within Plymouth and Norfolk Counties.

During the five month investigation, approximately 70 persons were identified as suspects who had passed false prescriptions. Yesterday, arrest warrants for the 70 suspects were sought and obtained from various District Courts in Plymouth County and Norfolk County.

Today, in the early morning hours, over 200 law enforcement officers swept communities in both counties and arrested the wanted individuals.

In praising the hard work of investigators over the last five months Plymouth County District Attorney Timothy J. Cruz stated:
