## **DCR UNVEILS NEW LIFEGUARD STATION AT SALISBURY BEACH STATE RESERVATION**

The Department of Conservation and Recreation (DCR) today celebrated two recently completed projects at Salisbury Beach State Reservation in Salisbury.

The new \$1.5 million Beach Services/Lifeguard Command Center replaces a much older facility that was razed. The new building features medical and first aid facilities as well as a radio room and office and meeting, training, and changing rooms for lifeguards. The new building has an environmentally friendly design: It sits on pilings 3 feet above the dune to allow the dunes to migrate underneath and let high tides run underneath.

The second project is a new shade shelter on the boardwalk leading from the parking lot to the beach. Funded with \$100,000 through DCR's Partnerships Matching Funds Program, it is a partnership between DCR and the Melanoma Foundation. The 1,000-square-foot wooden shelter is also elevated 3 feet above the dune, and offers outstanding views of the beach. It is fully handicap accessible via a ramp from the parking lot.

Members of the family of the late Paul Sullivan, a popular radio talk show host for many years on WBZ-AM radio who passed away last year from cancer, were actively involved in supporting this project.

"The new lifeguard command center and shade shelter will provide a balanced approach to enjoying the ocean and sun for thousands of visitors to Salisbury Beach," said State Senator Steven A. Baddour. "I'd like to thank DCR for their commitment and attention to preserving one of the best beaches in our state."

"The unveiling of this new lifeguard station and shade shelter demonstrates the Department of Conservation and Recreation's continued commitment to the preservation and enhancement of Salisbury Beach," said State Representative Michael A. Costello. "These modern facilities will help our lifeguards ensure the safety of the thousands of people who visit the beach each year."

Salisbury Beach State Reservation is the busiest day use and camping facility in the Massachusetts State Park system, attracting more than 1 million visitors each year. The
