Notification Form: Wood Chipping/Shredding Operation

310 CMR 16.00: SITE ASSIGNMENT REGULATIONS FOR SOLID WASTE FACILITIES

Instructions: Under 310 CMR 16.05(5)(e), a wood chipping and/or shredding operation is considered a Conditionally Exempt Recycling Operation that does not require a solid waste facility site assignment, provided: the operator accepts only clean wood as established in the regulations; uses good management practices; prevents unpermitted discharges of pollutants to air, water and other natural resources of the Commonwealth; and creates no public nuisance conditions. The operator must file this notice with the MassDEP Regional Office for the community where the operation is located (see the list on the following page) and with the local Board of Health at least 30 days before commencing operations.
