### Notes

- OSD reserves the right to add materials after contract signing, if mutually agreeable.
- In the event that a purchasing department requests pick up of a quantity less than unit identified above, the Contractor(s) will quote a prorated rate for that amount, in addition to other charges required to safely transport that waste material.
- Contractor(s) may request a change in management method for any waste material in writing, provided a reasonable explanation is given. However Contractor(s) may change their management method only with written permission from the PMT or OSD.
- This is the maximum allowable price that can be charged for this waste item, unless a change is negotiated with OSD in writing.
- Removal of bulk flammable waste requires an intrinsically safe truck.
- Packing materials, such as vermiculite, **must** be included in the price.
