- Containers ordered will be delivered to your municipality's specified location within 30 days of contractor's receipt of purchase order AND unloaded to either a loading dock or to the ground (whichever the municipality needs).
- Vendor may NOT charge any additional fees for delivery, labor or equipment above the state contract price. The state contract prices include ALL delivery and unloading costs.

CURBSIDE/SETOUT CONTAINERS

The Contractor **must** guarantee that any order not exceeding 30,000 containers shall be delivered within 30 days of Contractor's receipt of the purchase order from any eligible contract user. The Contractor shall further guarantee that purchase orders in excess of 30,000 containers **must** be delivered within 60 days of the Contractor's receipt of the order. The Contractor shall be assessed a penalty of \$0.05 per unit per day for each day the set out containers are not delivered within the time frame specified.

The Contractor must guarantee that any order not exceeding 2,000 carts shall be delivered within 30 days of the Contractor's receipt of purchase order from any eligible contract user. The Contractor shall further guarantee that purchase orders in excess of 2,000 must be delivered within 60 days of the Contractor's receipt of the purchase order. The Contractor shall be assessed a penalty of \$0.50 per unit per day that the wheeled recycling carts are not delivered in the time frame specified.
