Report on Part II Exam

There was a Part II Exam on January 15, with 30 of the applicants passing and 11 failing. The next two exams will be April 2 and July 30

December 2012 Correspondence from Attorney James Castleman

Deputy Commissioner and General Counsel, Robert Whitney presented the Board with a letter addressing the issues brought by The Alliance of Automotive Service Providers of Massachusetts, Inc. on ADALB Complaint 2012-03 and, in pertinent part, came to the following conclusions:

"In its complaint, the AASP appears to be arguing that the provision in 212 CMR 2.04 that states that an appraiser "shall personally inspect the damaged motor vehicle," requires that an appraiser be *physically* present in the repair shop in order to be able to conduct an appraisal. *See* February 7, 2012, Letter at 3. The Division, however, recognizes that the availability of online, real time digital video and photographs can permit the reliable and accurate transmission of information about the damage to motor vehicle to an appraiser who is in a remote location and who is not physically present beside the damaged vehicle during the inspection. Therefore, the Division concludes that an appraiser is permitted under 212 CMR 2.04, to conduct a personal inspection of a damaged vehicle from a remote location under certain circumstances, and does not need to be *physically* present in the repair shop where the vehicle is located."

Mr. Whitney noted that the Division of Insurance had been in communication with representatives of MetLife, who have agreed to amend the existing MetLife Direct Payment Plan so as to provide for a remote appraisal process utilizing one or both of the "personal inspection" methods described in Mr. Whitney's letter, and MetLife will then submit the amended plan to the Division for review and approval.

T. McClements presented the Board with a memo that stated the following:

- Metlife over applied when they submitted their application for PASS Program.
- After reviewing 211 CMR 123, Mr. McClements believes that the omission is deliberate because any correspondence regarding the conduct of licensed appraisers in the Commonwealth would have to come before the Auto Damage Licensing Board ("The Board").
- If 211 CMR 123 had any defining language regarding the conduct of appraisers in Massachusetts it would be in direct conflict with MGL c. 26, §8G.
- If Metlife had any questions regarding the proper conduct of appraisers in the Commonwealth, they should ask The Board.

C. Garcia presented the Board with his notes from the previous meeting that included the following questions:

- If a licensed appraiser did a physical inspection of a vehicle, can another appraiser change the appraiser's interpretation of the damage without a vehicle inspect?
- If there new technology out there that should take precedent over a others?
- Should desk review estimates be limited under a certain dollar amount?

The Division has been in communication with MetLife, who have agreed to amend the existing Direct Payment Plan.
