Head Boat Relief Program Recap

- \$416,000 in total funding
- Tier head boat pool by:
 - Vessel size: ≤40′, 41′ to ≤65′, 66′+
 - Activity: Inactive (<10 trips/ineligible), Limited (10 40 trips), Active (41+ trips)
- Bin shares: Active scaled from 0.25 to 1; Limited is ¼ of Active ("Example 4")
- Applicant can appeal pre-assigned bin, submitting additional docs (i.e., vessel registration, logbooks).
- Payments made per eligible permitted vessel (i.e., no cap for multi-vessel owners).
- All appeals to be settled before any payments made;
 still aiming for end of month.

For-Hire Sector: General Eligibility Proposal


- Must hold a current (2020) for-hire permit as of June 1.
- 2. Must have held a 2019 for-hire permit.
- 3. Must meet a threshold of activity to be eligible; remaining pool to be tiered.
- 4. Must be 18 years of age or older.
- 5. Must not be in violation of several federal laws.
- 6. Must be a MA resident <u>or</u> not be receiving CARES Act Sec. 12005 for-hire fishing aid from another state.
- 7. Must have suffered 35% revenue loss during March— June compared to prior 5-year average.
- 8. Assistance from this and other CARES relief must not make the applicant more than whole.


- 650 CB permits issued through May 31, 2020.
- Typically 800+ CB permits issued per year.
- From June 1-18, another 46 were issued.
- DMF data entry on mailed permit applications has experienced some delays; "issue date" in database reflects when entered, not when mailed by applicant or received at DMF.
- Understandable that some individuals may have delayed application this year due to uncertainties of fishing, health conditions, etc.
- Recommendation: stick with June 1 deadline plus 15-day grace period.



Charter Boat: Tiering Proposal

- \$584,000 in total funding
- Use available data to pre-assign permits to bins (rather than requesting new data from all permit holders).
- Tier charter boat pool by: activity level and possibly size.
 - Self-reported activity level from VTRs and/or permitting questionnaire; highest value 2018-2019.
- Payments made per eligible permitted vessel (i.e., no cap for multi-vessel owners).
