# 1.0 Previous Plan Review

Previously adopted plans provided the foundation of *Beyond Mobility*. Inventorying existing plans provided an opportunity to identify common visions, needs, recommendations and performance measures and examine any gaps between existing MassDOT plans, policies, and programs and the *Beyond Mobility* vision for transportation. In order to better understand the current state of planning within the Commonwealth, MassDOT developed an inventory of plans, policies, and directives in the state (“Plan Inventory”), as demonstrated in Figure 1.1. The Plan Inventory represents planning efforts across Massachusetts at the local, regional, and statewide levels.

Previous plans informed the understanding of the key phases of the *Beyond Mobility* planning process. In total, 90 plans were reviewed, ranging from modal plans to high-level policy documents. Key information for the following categories was collected from each plan:

- Barrier & Problem Statements:** Plans identified a range of problems, from site-specific issues (e.g., roadway bottlenecks) to broad issues (e.g., housing affordability).
- Visions:** Plans identified visioning content by many different names, including terms such as “guiding principle” or “values.” In several plans that lacked a clear vision statement, objectives or goals were included.



- Actions:** Plans differed in how they referred to and structured actions or recommendations. In some plans, “tactics” and “strategies” fulfilled a role as actions. Actions vary across types (capital programming, policy and program, performance and planning, organizational, or partnership and engagement).
- Performance Measures:** Many plans also established performance measures or metrics to measure progress towards goals. These measures were identified according to performance goal category as well as performance targets, if applicable.

Previous plans provided the foundation for several tasks of *Beyond Mobility*, including defining the Priority Area vision statements, understanding problems and barriers, measuring performance, and developing Action Items.

Table 1.1 provides an overview of the previous plans reviewed as part of the *Beyond Mobility* previous plan inventory.
