## **Building the Stakeholder Group**

Working with the Department of Conservation and Recreation (DCR), local elected officials, and staff from the City of Cambridge and Town of Watertown, the project team collected a large list of potential stakeholder candidates and put out a call for participants in Spring 2016. The call encouraged the recipients to apply to become stakeholders and also to send the call forward to others they may know who would be interested.

The final stakeholder list was intentionally chosen to represent a wide cross-section of interests, including a spectrum of local residents, businesses, and institutions, Watertown commuters, and users of various transportation modes. The list was geographically and topically diverse. At the initial stakeholder meeting, the crowd was asked to

verify that the stakeholder list was adequate, and community members suggested some small adjustments, which were made.

Late in the process, a flaw was identified in that the neighborhood of Strawberry Hill was underrepresented. One of the original participants lived in Strawberry Hill, however they moved away early in the process and left an open seat that was unfortunately not replaced. This flaw is noted here to inform the next stage in design, to ensure that Strawberry Hill has ample representation.


