Training Opportunities VIP Electronic Death Registration System (EDRS) and Changes to the Death Certification Process

The EDRS was implemented on September 1, 2014. To assist the user community in transitioning to the new process, the Registry of Vital Records and Statistics has offered weekly in-person Round Table Discussions and Demonstrations. Starting in November, the Registry will support in-person Discussion and Demonstration Sessions by request. The primary audiences are:

- 1. Medical Facilities staff; staff physicians and physicians with admitting privileges to discuss changes to the certification process and enrollment.
- 2. City and Town Clerks and Staff to demonstrate and answer questions regarding the amendment process.

Sessions for other communities can be accommodated. The Registry can offer the use of the large conference room in Dorchester for interested groups up to 30 that do not have a facility in which to meet.

To support ongoing training needs, the Registry has provided pre-recorded webinars for each user role that can be taken by interested users at any time. The practice environment, The Sandbox, is also available 24 hours / 7 days a week for users to practice in.

- Never use actual social security numbers. Use only 999-99-9999 and confirm that the SSN is unknown.
- If the last name of the decedent is a city or town name, that record is being used by that city or town to practice with partners. If it is not your record, please use another.
