PLEASE NOTE:

Starting April 15, 2021, DPH has updated its weekly report to remove any long term care deaths attributed to residents who had recovered from COVID, in alignment with the US Centers for Disease Control and Prevention's National Health Care Safety Network requirements for long term care facilities. This data is already collected by DPH and submitted to the CDC, and is consistent with how other states report this data using a more precise definition.

Starting April 15, 2021 DPH has updated its weekly report to remove any deaths attributed to residents who had recovered from COVID-19, in alignment with the US Centers for Disease Control and Prevention's National Health Care Safety Network requirements for long term care facilities. When the number of deaths is between 1-4 residents, the number is suppressed to protect the identity of the resident(s).

ALSO: Data on deaths is self-reported by each facility. Nursing homes and rest homes are required to report deaths from COVID-19 among residents who died at the facility, at a hospital or other location.

DPH performs routine data quality reviews of the data it receives. This includes removing duplicate results and updating counts, if needed. Also, negative tests results from nursing home residents who were first reported as presumptive positive are removed.

As a result of this data cleaning process and to ensure accuracy, the total number of cases and self-reported deaths may fluctuate. Sources: MAVEN for confirmed cases; Individual facilities for resident deaths to DPH Bureau of Health Care Safety and Quality's Chapter 93 Reporting System (REDCap).

Long-Term Care Staff Surveillance Testing

- On June 30, 2020, the Commonwealth issued an evidence-based surveillance testing policy for long-term care facilities to further support the safe care of vulnerable residents in these settings. This <u>testing policy</u> has been updated to align with federal policy and as more is learned about COVID-19
- Nursing facilities and rest homes are required to comply with the surveillance testing regimen, and may be subject to financial sanctions for non-compliance
- Nursing facilities and rest homes were required to perform baseline testing of at least 90% of staff by July 19, 2020
- Facilities are required to conduct surveillance testing weekly among staff who are not fully vaccinated against COVID-19
- This report includes information on the percentage of staff tested at each facility from the latest complete reporting period, and whether a facility was in compliance with state requirements
- The state is supporting surveillance testing costs for nursing facilities and rest homes

Massachusetts Department of Public Health COVID-19 Dashboard Infection Control Surveys

DPH serves as the State Survey Agency (SA) that submits COVID-19 nursing home data on behalf of Massachusetts to the Centers for Medicare & Medicaid Services (CMS). As outlined in the <u>June 1st CMS memorandum</u> CMS updated its COVID-19 reporting requirements to ensure 100% of Medicare- and Medicaid-certified nursing homes receive on-site review to mitigate the spread of COVID-19. Reporting requirements apply *only* to Medicare- and Medicaid-certified nursing homes, not *all* facilities in the state.

Multiple Surveys Explained: CMS requires states perform COVID-19 survey activities in addition to completing the required Focused Infection Control (FIC) surveys of 100% of Medicare- and Medicaid-certified nursing homes by July 31, 2020. Additionally, CMS requires states perform on-site infection control surveys within three-to-five days of identification of any nursing home with three or more new COVID-19 suspected and confirmed cases since their last National Healthcare Safety Network (NHSN) COVID-19 report or any nursing home in which one confirmed resident case is present in a facility that was previously COVID-free. As facilities may require a number of on-site infection control surveys, we show here the results of the five most recent surveys. Because CMS incorporates the FIC survey tool into recertification surveys, this report likewise includes such surveys.

Deficiencies Explained:

- The **severity** level reflects the impact of the deficiency and is categorized by four levels of harm.
- The **scope** level of a deficiency reflects how many residents were affected by the deficiency.
- For each deficiency, the DPH survey team determines the level of harm (**severity**) to the resident or resident(s) involved and then determines the **scope** of the problem within the nursing home.
- The team assigns an alphabetical Severity and Scope value to the deficiency. In the report below, the alphabetical values are A through L. Values closer to A signify lower scope and severity. Values closer to L (i.e. G or higher) signify higher scope and severity.
- The key at the bottom of each page indicates the level of deficiencies reported, which corresponds to dots of different colors:
 Green = Survey with no infection control-related deficiencies; Yellow = D-level deficiency; Pink = E/F-level deficiency;
 Red = G or higher

371 facilities received a combined total of 2,059 Infection Control Surveys between June 1, 2020 and May 28, 2021. Between May 24 – 28, 2021, 11 new surveys were mailed to facilities. Of those 11 new surveys:

The Centers for Medicare and Medicaid Services (CMS) requires infection control surveys to be conducted at all Medicare- and Medicaid-certified nursing homes as defined in the following link: https://www.cms.gov/files/document/qso-20-31-all.pdf. DPH conducts these surveys on behalf of CMS.

Some facilities that meet certain CMS requirements have been surveyed more than once. Follow-up infection control surveys must be conducted within three-to-five days when: (1) one confirmed COVID-19 case is reported in a nursing home that previously did not have any COVID-19 cases, and (2) three or more new suspected and confirmed cases are reported in nursing homes in one week that had previously reported a case.
