

This is a list of registered Third-Party Inspectors (TPI) for solid waste facilities that MassDEP is required to create and maintain in accordance with 310 CMR 19.018(5)(d)1. The individuals on this list have demonstrated, through submission of a BWPSW48 "Third-Party Inspector Qualifications Statement" application, they meet the minimum qualifications at 310 CMR 19.018(5) to conduct the type of Third-Party Inspection for which they are listed.

In accordance with 19.018(5)(a)2 a qualifications statement renewal must be submitted every two (2) years. A BWPSW48 renewal application should be submitted at least 60 days before the expiration date (see list) of the registration if the TPI wishes to remain on the list.

#### **Notes**

Individuals that are listed as O&M inspectors may perform O&M inspections at ALL SOLID WASTE facilities. However, in order to conduct an O&M inspection of a Construction and Demolition (C&D) waste processing facility or C&D waste transfer facility, a third-party inspector shall also have a valid Asbestos Inspector Certification from the Massachusetts Department of Labor Standards or sub-contract with an individual who has such certification for conducting asbestos-related inspection activities. (The contracted individual does not need to be listed with MassDEP as a Third-Party Inspector.)

This list reflects BWPSW48 applications approved by MassDEP as of 1/7/2017. If a BWPSW48 application was submitted but the applicant is not listed then the application was incomplete, it did not contain sufficient information to demonstrate that the applicant met the minimum qualifications or MassDEP has not finished the review. In such circumstances where more information is necessary to complete the review, MassDEP will notify the applicant and request additional information or the applicant may call Thomas Adamczyk at 617-574-6867.

Individuals that requested listing as a Waste Ban (WB) Inspector but have not completed the MassDEP waste ban training at the time the application was submitted will not be listed as waste ban inspectors until they have taken the training and notified MassDEP upon completion of the training and the date completed. MassDEP expects to update the list of registered TPI at least once every other month.

#### **Abbreviations Defined**

**WB** = Waste Ban Inspector with MassDEP training.

**O&M** = Solid Waste Facility Operation & Maintenance Inspector.

**Asbestos** = Massachusetts Department of Labor Standards (MDLS) Asbestos Certification.

#### **Examples of Listing:**

**WB/O&M** = A person who has taken the MassDEP training and therefore is a third-party waste ban inspector and a third-party operation & maintenance Inspector for solid waste facilities but does not hold a valid Massachusetts Department of Labor Standards asbestos certification.

**CWB/O&M/Asbestos** = A person who is a conditional waste ban inspector as described above and is a solid waste facility operation and maintenance inspector that holds a valid Massachusetts Department of Labor Standards asbestos certification.
