### FINAL DECISION

I have reviewed the attached Administrative Consent Order with Penalty – Acceptance of Settlement signed by Elizabeth Shin Perry, DMD on May 3, 2013, and by Geri Lambert for the Department on April 14, 2013 (ACOP-BO-13-Hn-Z001-SETT).

The petitioner is ordered to pay a civil administrative penalty in the amount of four hundred dollars (\$400.00) in accordance with the schedule and terms of paragraphs 2 and 3 of the Administrative Consent Order with Penalty. Payment is due within thirty days of the date of this Final Decision.
