

FINAL DECISION

I adopt the Recommended Final Decision of the Presiding Officer. I add that the Presiding Officer assigned to an adjudicatory appeal is responsible for maintaining the dignity and decorum of the proceedings. Counsel, parties, witnesses, and Department personnel are required to comply with the Adjudicatory Proceeding Rules and the Presiding Officer's Orders. All participants are expected to refrain from undignified and discourteous conduct that is degrading to the proceedings. Under no circumstances will rude and offensive behavior, including displays of verbal or physical conduct that denigrates or shows hostility or aversion toward a person on the basis of race, gender, religion, national origin, ethnicity, disability, age, sexual orientation, marital status, socioeconomic status, or political affiliation, toward opposing counsel, parties, and witnesses, be tolerated in the course of the proceedings. I impress that *pro se* litigants will be held to the same standard as attorneys in this regard.

The parties to this proceeding are notified of their right to file a motion for reconsideration of this decision, pursuant to 310 CMR 1.01(14)(d). The motion must be filed with the Case Administrator and served on all parties within seven business days of the postmark date of this decision. A person who has the right to seek judicial review may appeal this decision to the Superior Court pursuant to M.G.L. c. 30A, §14(1). The complaint must be filed in the Court within thirty days of receipt of this decision.
