

## FINAL DECISION

I have reviewed the attached Administrative Consent Order with Penalty and Notice of Noncompliance signed on August 5, 2016 by Floyd Silvia, Manager of S & G Associates, LLC, and on August 17, 2016 by Millie Garcia-Serrano, Regional Director for the Department (ACOP-SE-16-3T-Z001-SETT).

The Department issues this Final Decision incorporating the Administrative Consent Order with Penalty. The petitioner is ordered to pay a civil administrative penalty of twenty thousand dollars (\$20,000) with a suspended amount of ten thousand dollars (\$10,000) contingent upon the petitioner's compliance with the terms of the settlement agreement and in accordance with paragraphs 10, 16 and 26 of the Administrative Consent Order. Under the terms of 310 CMR 1.01(8)(c), this proceeding is dismissed with the parties waiving whatever rights they may have to further administrative review before the Department as well as any appeal to court.
