Injury-related Emergency Dept. Visits MA Youth & Young Adults, Ages 15-24 Years

There were **144,416** injury-related emergency department (ED) visits among Massachusetts youth between the ages of 15-24 years in FY2007. About 1 in 6 youth in this age group suffered an injury. The leading injury cause among this age group were motor vehicles; 1 in 42 youth suffered a motor vehicle injury.

This framework does not provide for intentionality for certain cause categories as indicated by gray shading. Injury subcategories are italicized.
