CONSENT AGREEMENT FOR PERMANENT REVOCATION

The Massachusetts Board of Registration in Nursing (Board) and Claudel Jean Baptiste (Licensee), a Licensed Practical Nurse (LPN) licensed by the Board, License No. LN91567, do hereby stipulate and agree that the following information shall be entered into and become a permanent part of the Licensee's record maintained by the Board:

1. The Licensee acknowledges that a complaint has been filed with the Board against his Massachusetts Licensed Practical Nurse license (license<sup>1</sup>) related to the conduct set forth in paragraph 2, identified as Docket No. NUR-2015-0142 (the Complaint).
2. The Licensee admits that on or about March 30, 2014, he submitted or directed another person to submit, on his behalf, an application for licensure as a Licensed Practical Nurse by reciprocity. On his application, he indicated that the Louisiana State Board of Nursing issued a Licensed Practical Nurse (LPN) license (#1315) to him on June 20, 2007. The Licensee admits that the information was not truthful or accurate because he never possessed an LPN license from Louisiana. He admits that he submitted or directed another person to submit, on his behalf, fraudulent documents to obtain a Massachusetts LPN license. He further admits that he has presented himself as a duly licensed LPN in Massachusetts and that he has engaged in the practice of nursing in Massachusetts.

In addition, the Licensee admits that on or about July 26, 2015, he submitted or directed another person to submit, on his behalf, an application for licensure as a Registered Nurse by reciprocity. On his application, he indicated that the Hawaii Board of Nursing issued a Registered Nurse (RN) license (#199881) to him on February 10, 2015. The Licensee admits that the information was not truthful or

accurate because he never possessed an RN license from Hawaii. He admits that he submitted or directed another person to submit, on his behalf, fraudulent documents in an attempt to obtain a Massachusetts RN license.

The Licensee acknowledges that his conduct constitutes a lack of Good Moral Character as it relates to the Board's Licensure Policy 00-01 and that said conduct fails to comply with the Board's Standards of Conduct at 244 Code of Massachusetts Regulations (CMR) 9.03(1), (34) and (47). He further acknowledges that his conduct warrants disciplinary action by the Board under Massachusetts General Laws (G.L.) Chapter 112, sections 61, 74, 74A and Board regulations at 244 CMR 7.04, Disciplinary Actions.

3. The Licensee agrees to a permanent revocation of his nursing license commencing with the date on which the Board signs this Agreement (Effective Date).
4. The Licensee agrees that he will not practice as a Licensed Practical Nurse in Massachusetts from the Effective Date<sup>2</sup>.
5. The Board agrees that in return for the Licensee's execution of this Agreement it will not prosecute the complaint.
6. The Licensee understands that he has a right to formal adjudicatory hearing concerning the allegations against him and that during said adjudication he would possess the right to confront and cross-examine witnesses, to call witnesses, to present evidence, to testify on his own behalf, to contest the allegations, to present oral argument, to appeal to the courts, and all other rights as set forth in the Massachusetts Administrative Procedures Act, G. L. c. 30A, and the Standard Adjudicatory Rules of Practice and Procedure, 801 CMR 1.01 *et seq.* The Licensee further understands that by executing this Agreement he is knowingly and voluntarily waiving his right to a formal adjudication of the complaint.
7. The Licensee acknowledges that he has been at all times free to seek and use legal counsel in connection with the complaint and this Agreement.
8. The Licensee acknowledges that after the Effective Date, the Agreement constitutes a public record of disciplinary action by the Board. The Board may forward a copy of this Agreement to other licensing boards, law enforcement entities, and other individuals or entities as required or permitted by law.

<sup>2</sup> The Licensee understands that practice as a Licensed Practical Nurse includes, but is not limited to, seeking and/or accepting a paid or voluntary position as a Licensed Practical Nurse, or a paid or voluntary position requiring that the applicant hold a current Licensed Practical Nurse license. The Licensee further understands that if he accepts a voluntary or paid position as a Licensed Practical Nurse, or engages in any practice of nursing after the Effective Date, evidence of such practice shall be grounds for the Board's referral of any such unlicensed practice to the appropriate law enforcement authorities for prosecution, as set forth in G. L. c. 112, ss. 65 and 80A.

9. The Licensee certifies that he has read this Agreement. The Licensee understands and agrees that entering into this Agreement is a final act and not subject to reconsideration, appeal or judicial review.
