

MassHealth 5010 Final Vendor Testing Status – 3/1/2012

As of 2/29/2012, MassHealth officially completed the 5010 implementation project testing phase. As of 3/1/2012, any electronic transaction testing is now considered part of normal operational testing, and is coordinated by MassHealth Customer Service at 1-800-841-2900. As a result, this is the last update that will be made to this list as part of the 5010 post-implementation project phase. If you use a vendor on this list that has a status other than “Testing Completed Successfully,” you may call MassHealth Customer Service to see if the vendor has taken the necessary steps to complete testing and are authorized to submit transactions on behalf of MassHealth providers.
