Female Offenders and Massachusetts County Corrections

Which counties house female offenders?

There are 13 counties in Massachusetts that have Sheriffs and adult correctional facilities. Each county submits daily "counts" of their Houses of Correction (HOC) and Jail populations to the Department of Correction (DOC), which are incorporated into a daily "count sheet" disseminated weekly. The data herein is based on those figures, representing county's counts of their female populations on the first Monday of each month July 2005-June 2006 (FY2006).



Which counties house the most females?

- Suffolk County housed the largest number of females, in general, but only in their HOC.
- 5 counties (Barnstable, Berkshire, Bristol, Hampden and Suffolk) housed both HOC and Jail female offenders;
- 6 counties (Dukes, Franklin, Middlesex, Norfolk, Plymouth, and Worcester did not house females;
- 1 (Essex) housed a portion of their HOC female offenders;
- 1 (Hampshire) housed just their jailed females;

Figure 1: Total Female Populations * in County House of Corrections and Jails* FY2006:

- The number of sentenced females in county HOC's increased by 25% during the fiscal year July 2005-June 2006;
- Total HOC female counts increased 19% from 385 in July 05 to 506 in June 2006;
- The number of females awaiting trial in county jails dropped from a high of n=255 in July 2005 to n=147 in January 2006, back up to n=172 in June 2006; the decrease from July 2005 to June 2006 was 33%.

Tables 2 and 3 provide totals for each county on the first Monday of each month in FY06, by HOC (Table 2) and jail (Table3)

- Though each county that housed females experienced a fair amount of monthly fluctuation in their population counts, the most pronounced were among Hampden and Suffolk counties.
- Bristol County’s history of being one of the only counties to house females from other counties impacted their range in their female population counts as well. Information submitted does not identify which “other” county females are housed in Bristol, but it appears at least a portion are Suffolk County Detainees.



- The number of females in county jails declined for most counties in FY06, except Hampden;
- Hampden county jails reported an increase from 50 in July 2005 to 74 in June 2006, representing a 33% increase;
- Suffolk county jail apparently ceased housing females after March 2006, reporting 62 in July 2005, then 40 in August to a range of 0-5 for the following seven months.



Figure 2: Bristol County Female Offender Population* FY2006





Tables 4 & 5 reflect the count of county females on the first Monday of each month in FY 06 in DOC custody.

- The daily count of sentenced county females in DOC custody fluctuated throughout FY06, ranging from a low of 298 to a high of 359, averaging 316.
- County females from Essex, Middlesex and Worcester represented the highest numbers in DOC custody.
- The upward trend of county sentenced females, in DOC custody toward the end of FY 06 is supported by a recent count of 362 on October 2, 2006.

Figure 5: Female county Inmates in DOC Facilities FY2006





Figure 6 reflects the combined totals of county sentenced females and awaiting trial detainees combining these state wide totals in County and DOC custody.

Figure 6: Total Female County Inmates in DOC & County Facilities FY2006



- The total number of county sentenced females increased 18% from 705 to 865 during FY 06.
- In comparison, the total number of county females awaiting trail decreased 29% from 255 to 180, with a fair amount of fluctuation throughout FY 06.
- While the total number of county females was 1,194 in June2006 it continued to rise to 1,211 by October 2006.

Table 6 combines the **total number of county females awaiting trial** in both County jails and DOC custody (MCI-Framingham) on **October 2, 2006**.

- The data suggests that the 31 “other county” females housed in Bristol county represent Suffolk county’s female detainee population.
- Western Massachusetts counties (Berkshire, Franklin, Hampden & Hampshire) combined number of female county detainees totaled 107 (none resided in a DOC facility).
- Females criminally sentenced to Essex County are sent to the DOC and remain in DOC custody, except for those meeting the criteria and selected to participate in Essex County Sheriff’s Women in Transition (WIT) program who are then transferred to Essex County for this pre-release program.
- County females awaiting trial in DOC custody from Essex (56), Worcester (49), and Middlesex (33) counties together (138) comprised 81% of county females awaiting trial in DOC Custody and 36% of ALL county females awaiting trial statewide.
- While Middlesex County represents the fourth largest number of the female county sentenced population (n=82), neither they nor Worcester (n=75), Plymouth (n=51) or Norfolk (n=41) house any of their sentenced females.

Table 7 combines the **total number of *county sentenced females*** in both County custody (HOC's) and DOC custody (MCI-Framingham) on **October 2, 2006**.

- The largest number of *county sentenced* females come from Suffolk (23%), followed by Hampden (17%), where both County HOC's house the vast majority of their sentenced females.
- Essex had the third largest number of county sentenced females (16% of total county sentenced females), but only housed 36% of their total sentenced females (all of whom initially are in DOC custody).
- Among the *county sentenced* population if one were to combine those in Western Massachusetts counties (Berkshire, Franklin, Hampden & Hampshire), the number of females totals 169 (only 1 was in a DOC facility).
