Abstract

This report is a statistical description of the 2,848 individuals committed by the courts to a term of incarceration in the Massachusetts Department of Correction during the year 1987. The tables in this report contain information on the nature of present offense, personal background characteristics and criminal history of these individuals. Some highlights of the statistics presented in this report are:

- There was a 12 percent increase in the number of commitments during the year, from 2,533 in 1986 to 2,848 in 1987. The 2,848 commitments in 1987 represent the highest level of commitments in DOC history.
- There were 1,250 commitments to Cedar Junction (21 percent higher than 1986), 701 commitments to Concord (6 percent higher than 1986), and 897 commitments to Framingham (7 percent higher than 1986).
- Males are committed to Cedar Junction or Concord while females are committed to Framingham. Overall, there was a 15 percent increase in male commitments and a 7 percent increase in female commitments from 1986 to 1987.
- The median minimum sentence for Cedar Junction commitments was five years; the median maximum sentence for Concord commitments was eight years; and the median maximum sentence for Framingham commitments was less than 1 year. Sentence lengths for new court commitments were similar in 1986 and 1987.
- Violent offenses (person and sex) accounted for 52 percent of all male commitments and 10 percent of all female commitments. Non-violent offenses (property, drug and "other") represented 90 percent of all female commitments and 48 percent of all male commitments. From 1986 to 1987 there were increases in commitments for drug offenses (up 42 percent), property offenses (up 12 percent), person offenses (up 7 percent), and sex offenses (up 1 percent). There were decreases in commitments for other offenses (down 6 percent).
- The median age at commitment was 27 years.
- Fifty-eight percent of the commitment population were white (including white Hispanics); 62 percent were single; 10 percent had been in the military; 43 percent came from the Boston SMSA; most had limited work experience concentrated in the areas of manual labor and services; the median educational level was twelfth grade; and, 41 percent had a self-reported history of drug use.
- Fifty-seven percent were serving their first adult incarceration. The median age at first court appearance was eighteen.

Introduction

This report is a statistical description of individuals committed by the courts to the Massachusetts Department of Correction during 1987. The report contains information on the nature of the present offense, personal background characteristics and criminal history of individuals committed from the courts. Trends in court commitments over the last five to ten years are discussed as well. The information on which this report is based was submitted to the Research Division from the three committing institutions and the Board of Probation.

This report includes all new court commitments as well as those who began serving a new sentence during the year (forthwith and from and after sentences). If an individual was committed to the Department more than once during 1987 that individual is counted as multiple court commitments. Some categories of offenders are not included in this report, for example, those who began serving "B" and "C" sentences during 1987 (sentences received for crimes committed on parole).

The following information will be helpful in reading the tables in this report. Each table is divided according to committing institution. Since each committing institution receives a very different type of offender, it is important to consider each column in the table as well as the total column. The top number in each cell represents the number of individuals who fall into the corresponding category in the table. The bottom number in each cell appears in parentheses and represents the percentage of the number of individuals in a particular category to the total number of commitments from that institution (column percents).

Cases where information is unknown are also included in the tables and are included in the percentages. It is important to note the size of the "unknown" category. It is particularly large in some of the personal background characteristics variables (e.g. occupation and drug use). In the narrative, these cases are excluded when discussing percentages.

Trends in Court Commitments, 1977 to 1987

There were 2,848 commitments during 1987, a 12 percent increase from the previous year. Figure 1 (page 3) shows the number of commitments for the period 1977 to 1987. The number of commitments during 1987 was higher than at any time in the history of the DOC. The increase in commitments from 1986 to 1987 was the largest in the last five years, and represents the ninth straight year in which commitments increased.

Individuals are committed to one of three institutions: Cedar Junction, Concord or Framingham. Figure 2 (page 3) shows the number of commitments to each committing institution for the period 1977 to 1987. The number of commitments during 1987 was higher than any of the preceding eleven years for Cedar Junction and Framingham. Concord commitments peaked in 1982 at 726 commitments.

From 1986 to 1987 increases in commitment levels varied at the three committing institutions. Cedar Junction commitments increased from 1033 in 1986 to 1250 in 1987, an increase of 217 commitments or 21 percent. Concord commitments increased from 662 in 1986 to 701 in 1987, an increase of 39 commitments or 6 percent. Framingham increased from 838 commitments in 1986 to 897 in 1987, an increase of 59 commitments or 7 percent. Overall, male

1977 to 1987




commitments increased by 15 percent and female commitments increased by 7 percent.

Table 1 shows selected characteristics of offenders committed to the DOC over the last five years, 1983 to 1987. These characteristics are shown separately for each committing institution and for total commitments.

In terms of primary offense, the commitment population has changed over the past five years. Commitments for drug offenses increased by 388 percent (N=578), commitments for sex offenses increased by 66 percent (N=106), commitments for property offenses increased by 18 percent (N=99), commitments for other offenses increased by 12 percent (N=40), and commitments for person offenses decreased by one percent (N=10). Thus, in 1983, 50 percent of DOC commitments were for violent offenses (i.e. person and sex offenses) and 50 percent were for non-violent offenses (i.e. property, drug, and "other" offenses). In 1987, 39 percent of the commitments were for violent offenses and 61 percent were for non-violent offenses.

Commitment for drug offenses showed the greatest increase over the period. Drug commitments increased at all three committing institutions. Drug commitments were up by 552 percent (N=320) at Cedar Junction, by 321 percent (N=135) at Concord, and by 251 percent (N=123) at Framingham.

Commitments for sex offenses increased by 66 percent (N=106) over the period, from 161 in 1983 to 267 in 1987. All institutions experienced increases in commitments for sex offenses: Cedar Junction increased by 56 percent (N=60), Concord increased by 88 percent (N=42), and Framingham increased by 67 percent (N=4).

Commitments for property offenses increased at Cedar Junction by 35 percent (N=44) and at Framingham by 38 percent (N=87). Commitments for property offenses decreased at Concord by 18 percent (N=32).

Commitments for offenses in the "other" offense category increased by 12 percent (N=40) over the past five years. This growth was concentrated among the Framingham group where many women were committed for prostitution, O.U.I., disturbing the peace, or other offenses in this category. Commitments to Framingham in this category increased by 15 percent (N=41) over the period.

The number of offenders committed for offenses against the person declined from 855 in 1983 to 845 in 1987. This represents a decline of one percent (N=10), and was the only offense category where commitments declined over the period. Commitments for person offenses increased at Cedar Junction by 17 percent (N=72), and at Framingham by 11 percent (N=8) and decreased at Concord by 26 percent (N=90) during the past five years.

Patterns in sentence length over the past five years is considered separately for each committing institution. With the exception of lifers, there have been increases in all categories of sentence length at Cedar Junction during that period. There were decreases in all sentence length categories at Concord with the exception of the 5 to 9 year category. In 1983, 29% of all Concord commitments received sentences of 5 to 9 years. By 1987, 39% of all Concord commitments received sentences of that length. Women committed to Framingham can be serving either a county, reformatory, or prison sentence. Over the past five years the number of women committed with prison sentences increased 179 percent (N=43), the number of women committed with county sentences increased 44 percent (N=235), and the number of women committed with reformatory sentences decreased by 19 percent (N=15). Overall, in 1983, 84 percent of Framingham commitments were serving county sentences and 16 percent were serving state prison or reformatory sentences and in 1987, 85 percent were serving county sentences and 15 percent were serving state sentences.

The age distribution of individuals committed to the Department shifted

upward over this six year period. In 1983, 72 percent of the commitments were under 30 and 28 percent were 30 years or older. In contrast, by 1987, 61 percent were under 30 and 39 percent were 30 years or older. This shift in age distribution occurred at all three committing institutions.

A Description of 1987 Court Commitments

This section presents a general description of the population of individuals committed to the DOC during 1987. This discussion includes a description of the present offense, personal background characteristics and criminal history of the offender. Where appropriate, the three committing institutions are compared.

Nature of Present Offense

In discussing the present offense of the commitment population, the governing offense, that is the offense for which the person received the longest sentence, is considered.

Court of Commitment. Seventy-two percent of the commitments to the Department of Correction were from Superior Courts. Three courts, Suffolk Superior, Middlesex Superior and Worcester Superior, accounted for 46 percent of the commitments to the Department. All Cedar Junction commitments came from Superior Courts and 89 percent of all Concord commitments came from Superior Courts. In contrast, 18 percent of the commitments to Framingham were from Superior Courts. Most commitments to Framingham were from municipal and district courts (municipal courts are lower courts of Suffolk County and district courts are lower courts of all other counties with the exception of Brookline Municipal Court in Norfolk County).

Jail Credits. Jail credits measure the number of days that the individual was incarcerated while awaiting trial. A large number of jail credits is usually indicative of a serious crime or a low income offender. Seventy-four percent of Cedar Junction commitments had one or more days of jail credits. This contrasts with 58 percent of Concord commitments and 34 percent of Framingham

commitments. The median number of days of jail credits for all commitments was eight.

Minimum Sentence. Only those individuals who receive a state prison sentence (all Cedar Junction commitments and some Framingham commitments) receive a minimum sentence. Generally, minimum prison sentences must be for two and one-half years or more but in some cases can be shorter (some drug offenses carry short prison sentences, for example). The median minimum sentence for Cedar Junction commitments was five years. There were 67 commitments to Framingham who received prison sentences. The median minimum sentence for those women was four years.

Fifty-six individuals received life sentences during 1987, including one woman. The 56 life sentences included 29 for first-degree murder, 24 for second-degree murder, one for armed robbery and two for aggravated rape.

Maximum Sentence. All individuals committed to the Department have a maximum sentence. For Concord commitments this is their only sentence. Generally, maximum sentences to Concord are two and one-half years or longer but shorter sentences can be given for some offenses such as larceny, escape and drug offenses. The median maximum sentence for Concord commitments was eight years. A large proportion of Framingham commitments received county sentences, those with a maximum sentence length of less than two and one-half years. Males receiving county sentences are committed to houses of correction. In 1987 there were 32 females committed to houses of correction. All other females receiving county sentences were committed to Framingham. Of the 897 commitments to Framingham, 67 (8 percent) received prison (Cedar Junction) sentences, 65 (7 percent) received reformatory (Concord) sentences and 765 (85 percent) received county sentences, including 77 committed for non-payment of a fine.

Type of Sentence. Most individuals committed to the Department received simple sentences (35 percent) or concurrent sentences (34 percent). Less frequently received are aggregate, forthwith or from-and-after sentences. Forthwith sentences are commonly found among Cedar Junction commitments (16 percent); split sentences are commonly found among Concord (23 percent) and Framingham (22 percent) commitments; and nine percent of the Framingham commitments were in lieu of payment of a fine.

Offense. Type of offense varies by committing institution. Fifty-three percent of the commitments to Cedar Junction and 50 percent of the commitments to Concord were for violent offenses. In contrast, ten percent of the commitments to Framingham were for violent offenses. Most women were committed for property offenses (35 percent) or offenses in the "other" category (35 percent).

Offenses against the person accounted for 30 percent of all commitments to the Department and ranged from 40 percent to Cedar Junction, 37 percent to Concord, and 9 percent to Framingham. The most common offenses against the person were armed robbery (N=295), armed assault (N=169), and unarmed robbery (N=127). There were 136 commitments for homicides in 1987, including 29 for first degree murder, 25 for second degree murder and 82 for manslaughter.

Sex offenses accounted for nine percent of all commitments to the DOC including 13 percent to Cedar Junction and Concord, and one percent to Framingham. There were 215 commitments for rape during 1987 and 48 commitments for sexual assaults. Of the rapes and sexual assaults, 122 involved adult victims and 141 involved minors. Additionally, there were four commitments for other sex offenses during the year.

Property offenses accounted for 22 percent of all commitments to the Department, and ranged from 14 percent to Cedar Junction, 21 percent to

Concord, and 35 percent to Framingham. Burglary was the most common property offense for Cedar Junction and Concord commitments; larceny was the most common property offense for Framingham commitments.

Drug offenses accounted for 26 percent of all commitments during 1987 ranging from 30 percent to Cedar Junction, 25 percent to Concord, and 19 percent to Framingham. The most common drug offenses were violation of the Controlled Substance Act with a Class B substance (N=338) or Class A substance (N=186). The Class B substance category includes amphetamines, cocaine, barbiturates, and other substances. The Class A substance category includes heroin.

Offenses in the "other" category accounted for 3 percent of Cedar Junction commitments, 4 percent of Concord commitments and 35 percent of Framingham commitments or 13 percent of all commitments to the DOC. The most common offenses in this category were operating under the influence (N=100), prostitution (N=99), disturbing the peace (N=45), weapons offenses (N=39), and motor vehicle offenses (N=37).

Time Until Parole Eligibility. An indication of how much time offenders will actually serve is the time until their parole eligibility date. Over half of all offenders will be released at their original parole eligibility date. For Cedar Junction commitments the median time to serve was from 2 to 3 years; for Concord commitments the median time to serve was from 5 to 7 months; and for Framingham commitments the median time to serve was 3 months or less.

Individuals can have no parole eligibility for a number of reasons. Some mandatory sentences have no possible release to parole and some sentences are too short for parole eligibility to be established, i.e., less than sixty days. In a small number of cases individuals can be beyond their original parole eligibility at the time of commitment to the DOC if they were in jail for a sufficient time awaiting sentencing.

Age At Incarceration. The median age of offenders at incarceration was 27 years. Their ages ranged from 16 years to 77 years. The median age of Cedar Junction commitments was 28 years; the median age of Concord commitments was 25 years; and the median age of Framingham commitments was 27 years.

Personal Background Characteristics

In discussing the personal background characteristics of the commitment population, all information is reported according to the status of the offender at the time of commitment. Most of this information is self-reported by the offender and is not verified in any way.

Sex. All Cedar Junction and Concord commitments are males, all Framingham commitments are females. During 1987, 31 percent of the commitments were females and 69 percent were males.

Race and Ethnicity. Fifty-eight percent of the 1987 commitment group were white (including white Hispanics), 32 percent were black (including black Hispanics), and nine percent were identified as Hispanic (with no other race specified). There were also 8 Native Americans and 14 Asians committed to the DOC. Eighteen percent of the commitment group were Hispanic. This includes white Hispanics, black Hispanics and Hispanics whose race was otherwise not identified.

Citizenship. Ninety-five percent of the commitments were U.S. citizens and five percent were citizens of other countries. Sixty-one percent of the commitments were born in Massachusetts, 21 percent were born in other states, 11 percent were born in U.S. territories, and 2 percent were U.S. citizens born in other countries.

Marital Status. Most of the commitment group were single (62 percent). Eighteen percent were married at the time of their commitment, 11 percent divorced, seven percent separated, one percent widowed, and one percent common-law.

Military History. Ten percent of the commitment group had a history of military service and 90 percent had no military service. Seventy-one percent of the known veterans were honorably discharged from military service.

Prior Address. Almost all commitments (94 percent) were living in Massachusetts prior to incarceration. Three communities accounted for more than 100 commitments each: Boston (N=683), Worcester (N=281), and Springfield (N=168).

Occupation. Most of the individuals committed to the Department had previous work experience. This work experience was concentrated in the areas of manual labor (44 percent) and services (30 percent).

Education. The median educational level for this population was 12th grade. Fifty-one percent of the commitment group had completed at least high school, including 12 percent with some college education.

Drug Use. Forty-one percent of the commitments reported a history of prior drug use; including eight percent reporting a history of heroin use. Drug use history was generally based on offender self-reports.

Criminal History

Information about the criminal history of individuals committed to the DOC is taken from reports prepared by the Board of Probation and records submitted by District Courts. These reports identify the number of court appearances and the offenses that the individual was charged with as well as disposition information. In

this section the individual's history of court appearances, charges, incarcerations and paroles will be discussed.

Prior Court Appearances. The median number of prior court appearances was seven. Sixty-five percent had court appearances for person offenses, 72 percent for property offenses, 16 percent for sex offenses, 44 percent for narcotics offenses, 22 percent for alcohol offenses, and 6 percent for escape offenses.

Prior Incarcerations. Eleven percent had a history of one or more commitments to a juvenile authority; 37 percent had a history of incarceration in a county facility; and 14 percent had a history of incarceration in a state or federal facility. Fifty-seven percent were serving their first incarceration as an adult and forty-three percent had been previously incarcerated as an adult.

Parole History. The number of paroles and parole violations that an individual experienced prior to this commitment are shown on pages 53 to 55. Nine percent of the commitment group experienced paroles as an adult or juvenile in the past. Fifty-one percent of those with a history of paroles also had one or more parole violations.

Age at Entry Into Criminal Justice System. The age of the individual at first court appearance, first court appearance for a drug related offense, and first court appearance for an alcohol related offense are shown on pages 56 to 58. The median age at the time of first court appearance was 18 years of age.

GLOSSARY

OFFENSE

Armed Assault

Includes armed assault with intent to rob, armed assault in dwelling house, assault and battery with dangerous weapon, and assault with dangerous weapon.

Assault-Intent to Murder

Includes assault with intent to murder and attempt to murder.

Assault with Intent to Rape

Includes assault with intent to rape and indecent assault and battery.

Manslaughter

Includes vehicular homicide and manslaughter.

Other Person

Includes mayhem and confining a person for the purpose of stealing.

Prostitution

Includes prostitution and common night-walker.

Rape of Minor

Includes rape of female under sixteen, rape of child, and statutory rape.

Unarmed Assault

Includes unarmed assault with intent to rob, assault, assault and battery, and other assaults.

SENTENCE TYPE

Aggregate

Multiple sentences received for more than one offense. These sentences will be served consecutively.

Concurrent

Multiple sentences received for more than one offense. These sentences will be served simultaneously.

Fine

Incarceration resulting from non-payment of a fine for one or more offenses.

Forthwith

A sentence that is to be served effective immediately, regardless of other sentences for which the individual is currently incarcerated.

From and After

A sentence to be served following release from a previous sentence.

Simple

One sentence received for a single offense.

Split

A sentence that is divided between a specified period of incarceration followed by probation supervision.
