CRS INTERIM REPORT

INTRODUCTION

The Massachusetts Department of Correction, in response to the prevailing disenchantment with the effectiveness of traditional incarceration of offenders and the recognition of the valuable rehabilitative potential of community resources, is presently in the process of developing and implementing an extensive system of community corrections. According to current statistics, nearly all convicted offenders (98%) eventually return to the community and over two-thirds (70%) return within only two years of sentencing. It is evident then, that any realistic attempt to alter offender behavior must include consideration of the offender's adjustment in the community.

The Massachusetts system of community corrections was launched with the passage of the 1972 Correctional Reform Act (Chapter 777) which removed the pre-existing legal barriers to community programming. Inmate institutional leaves (furloughs)¹ were allowed for up to 14 days per year and the work and educational release programs were expanded to create wider offender eligibility. However, the most far-reaching component of this Act was the authorization of the establishment of small, **separately-operated**, community-based facilities to which offenders may be transferred prior to or subsequent to their release on parole.

The rationale behind these centers is the establishment of a smooth transition between total institutionalization and the nearly complete freedom of parole. Essentially community corrections is a continuum of increasing freedoms which inherently involve the accrual of greater responsibilities. The community pre and post-release centers represent a vital phase of this continuum. While

residing at these facilities, the offender will participate in work or educational programs and will receive counseling and other support services that will hopefully facilitate his re-adjustment into society.

The series of pre and post-release centers in Massachusetts is entitled the Community Release System (CRS). As of August 1, 1973, the CRS consisted of six half-way houses (post-release) and three pre-release centers. Halfway houses accept only those offenders who have in fact been paroled whereas the pre-release centers can accept residents within 18 months of their parole eligibility. Generally the average stay for a resident consists of three months. The yearly capacity of a center therefore is its bed capacity quadrupled.

POST-RELEASE

The genesis of the post-release component of the CRS program was on August 1, 1972 when the Department of Correction authorized and funded Mass. Halfway Houses, Inc. to provide 30 beds which would serve approximately 120 men during a 12 month period. At the time Mass. Halfway Houses consisted of Brooke House, located in the South End of Boston and Temporary Housing. Temporary Housing consists of a five bed unit within Brooke House for offenders whom are believed to need only one month of community residence rather than the standard three months. Mass. Halfway Inc. opened a third facility in January, 1973 entitled Coolidge House which provided an additional 15 beds.

A second private organization, The Peaceful Movement Committee, was authorized to operate a halfway house, and began accepting residents in November, 1972.² It has a capacity of 12 beds which can serve 48 men a year.

In March of 1973, the Roxbury Community Rehabilitation Center opened its doors for 25 residents.

A sixth post-release facility, Project Overcome, is operated by Mass. Halfway House, Inc. but is funded by the Parole Board rather than the Department of Correction. This unit, which services primarily offenders with drug problems, has a capacity of 25 beds.

PRE-RELEASE

At the time of this writing, three facilities are presently accepting residents on a pre-release status. Two of these centers, Boston State Pre-Release, located on the grounds of Boston State Hospital and Shirley Pre-Release, situated at the former Shirley Industrial School for Boys, are operated directly by the Department of Correction. They each have a capacity of 50 beds.

A third pre-release center serving female offenders opened in Dorchester, in September of 1973, Charlotte House, operated in conjunction with MCI-Framingham and sub-contracted to the Friends of Framingham, provides facilities for 12 women.

While methods of treatment and program structure varies among the centers it is expected that certain services will be common to all. These services include: (1) Counseling services, i.e. individual, group and family counseling; (2) Vocational counseling; (3) Arrangements for pre-vocational and vocational training; (4) Job development and job placement; (5) Arrangements for education, to include remedial education, G.E.D. certification and higher education; (6) Financial planning and management; (7) Arrangements for medical and legal services; (8) Recreational activities and (9) Participation in interagency programs (AA, Drug programs, etc.).

Residents of the Pre-Release Centers will be able to participate in work-release, educational and/or vocational training release, and the furlough program.

Since the Community Release System's inception on August 1, 1972 systematic data regarding the CRS has been maintained. The purpose of this report is to present certain preliminary information for planning and management purposes. This is the first on a series of interim reports, with the complete evaluation of the CRS occurring after three years project operation. Data included in this report is based on a period of one year, beginning August 1, 1972 with a cut-off data of July 31, 1973. It should be noted however, that not all facilities have been in operation for a full year. Charlotte House will not be considered as it opened following the cut-off date. Included in this report is: Statistical data regarding the movement of population in and out of both the halfway houses and pre-release centers; admission and release data; program termination information; a description of the background characteristics of program participants; and a **six**-month follow-up analysis of post-release program community adjustment.

PART I

MOVEMENT OF POPULATION STATISTICS

Parts I and II of the interim report contain a series of tables and pie graphs that summarize the movement of client population from MCI's into the pre and post release centers between November, 1972 and July, 1973.

This movement of population material includes: (1) a breakdown of the various sending institution with the proportion of clients that they provided for each of the CRS facilities;* (2) a breakdown of the type of release once the client terminated from the program; and (3) a series of pie graphs depicting the proportions of successful and unsuccessful completions.

From this material it can be seen that during the period between November 1972 and July 1973, 216 clients were received at pre-release facilities and 226 clients at post-release facilities. During the same time period 127 clients terminated from pre-release facilities and 187 from post-release facilities. Of the 127 pre-release terminations, 74 clients (58%) were successful program completions and 53 clients (42%) were program failures. The escape rate was 9% (11 clients). For post-release facilities, of the 187 clients terminations 76 were successful completions (41%) and 111 (59%) were program failures. A total of 50 clients were terminated for absence without leave. The AWOL rate was 27%.



PRE-RELEASE CENTERS: REASONS FOR PROGRAM TERMINATION



BOSTON STATE PRE-RELEASE CENTER






BROOKE HOUSE




POST-RELEASE CENTERS: REASONS FOR PROGRAM TERMINATION




POST-RELEASE CENTERS: REASONS FOR PROGRAM TERMINATION




PROJECT OVERCOME




PART III

CRIMINAL HISTORY BACKGROUND CHARACTERISTICS

As part III of the report an analysis of criminal history and background characteristics data was conducted on CRS participants according to their respective facility. However, because the client levels at the Peaceful Movement Committee and Roxbury Community Rehabilitation houses were too low for this type of statistical breakdown to be meaningful, they were excluded in the analysis.

The full tabular presentation of the variables included in the analysis for each facility is incorporated as Appendix II of this report. However, at this point we include a narrative summary of some of the more striking findings in the breakdown of the criminal-history and background characteristics for CRS participants as compared to the Massachusetts Correction Institution population as a whole.*

A. PRE-RELEASE CENTERS

A comparison of commitment, background, and criminal-history variables between the MCI population as a whole and the CRS pre-release clients produced 16 variables that yielded statistically significant differences.

The analysis of commitment variables revealed that a disproportionately higher number of pre-release clients were incarcerated for armed robbery; while a disproportionately lower number of pre-release clients were incarcerated for sex offenses that was true of the general institutional population. The pre-release client population also had a disproportionately lower number of 1st and 2nd degree murder offenders.

This material is summarized in Table I on the following page.

In terms of sentence type significantly more pre-release clients received indeterminate sentences that did the MCI population as a whole. This is largely due to the fact that indeterminate sentences are MCI-Concord sentences and MCI-Concord accounted for a large portion of the CRS client population. A comparison of current age revealed that the Pre-Release client population was significantly younger than the general MCI population. These results are summarized in Table II below:

Analysis of background variables yielded only one striking finding. In terms of marital status, a disproportionately higher number of pre-release clients were single. Approximately 61% of pre-release clients were single whereas 50% of the total MCI population were single.

The analysis of the criminal-history variables revealed ten items that produced statistically significant differences between the two samples. The variable History of drug arrests indicated that significantly more MCI residents than pre-release clients had no previous drug arrests. In terms of Known drug use, analysis revealed that more than half of the total MCI population were not known to have previously used drugs whereas only 37% of the pre-release population were not known to have used drugs. Thus, it is noted that a higher proportion of previously known drug users enter pre-release facilities. When this variable was further broken down it was discovered that more pre-release residents had a history of heroin use. These results are summarized in Table III on the following page.

The variable number of prior court appearances was analyzed in relation to the various offense categories. Significantly more pre-release residents (91%) had no previous court appearances for sex offenses as compared to the MCI population (76%). In regards to the number of prior court appearances for drug offenses, it was found that the MCI population contained disproportionately fewer residents with prior drug offenses. These results are summarized on page in Table IV.

One final criminal-history variable produced a difference between the two samples. An analyses of the variable, number of previous adult paroles, determined that approximately 75% of the pre-release population compared to approximately 60% of the MCI total population had no previous record of adult paroles. See Table VI below:

Under the general variable heading, prior incarceration, three items indicated noticeable differences between the two samples. The first variable, number of juvenile incarcerations, showed that significantly more MCI residents had no record of juvenile incarcerations. However, analysis of the number of prior House of Correction incarcerations and the number of prior State/Federal Incarcerations for the two samples revealed that the pre-release centers had significantly more clients without a history of such incarcerations. These results are presented as Table V below:

B. POST RELEASE CENTERS

An analysis of commitment, background and criminal-history variables was also conducted for the post-release facilities run by Massachusetts Half-way House.* The MCI's general population data was also used here for statistical comparisons.

A review of the commitment variables revealed that a higher portion of the MCI population were originally committed for an offense against the person than was true for the post-release clients. On the other hand, it was found that the post-release client population had a disproportionately higher number of property offenses. No resident of the post-release client population had been committed for either 1st or 2nd degree murder; while 13% of the MCI population had been committed for this offense. These results are summarized in Table VII.

A fourth commitment variable, type of sentence, indicated that a disproportionately higher number of the Massachusetts Half-way House post-release clients received sentences of indeterminate length than was true for the general population.

In terms of the criminal-history variables five items produced significant differences. When the variable age at first arrest was broken down, it was determined that 57% of the MHHI population were first arrested between the ages of 6 and 15, compared to 36% of the MCI sample.

A second variable yielding a significant difference between samples was the number of prior court appearances for person offenses. It was found that 24% of the Half-way House sample compared to 13% of the MCI group reported no prior court appearances for person offenses.

When the variable, number of prior State/Federal Incarcerations, was broken down it was found that a higher number of MCI clients reported no prior incarcerations.

A fourth variable in which a difference between samples occurred was, drug use. More MHHI residents (52.7%) had a record of drug use than did MCI inmates (42.6%). When this item was broken down further it paralleled the above finding and showed that more Half-way House residents had a history of heroin use than MCI inmates.

The results are presented on the following page at Table IX.

When comparing background variables between the two samples, two items; Marital Status and Last Civilian Address, yielded noticeable differences.

In regard to Marital Status it was determined that more Half-way House residents than MCI inmates were single. In keeping with the Half-way House policy of accepting those residents of the major institutions who will be returning to the highly populated cities and town throughout the state, it was found that more Half-way House residents than MCI clients listed Boston as their last civilian address. These statistics are presented below as Table X.

PART IV

CRS PARTICIPATION PROGRAM VARIABLES

Part IV of the report deals with program participation data. The Department of Corrections Research and Planning Division instituted a CRS reporting system whereby a series of data is systematically recorded by the staff at each facility. This data includes employment statistics, educational program statistics, treatment statistics, and other material related to specific programs and services utilized. The full tabular breakdown on clients that moved through the CRS facilities between the dates of November, 1972 and July, 1973 is included as Appendix III of this report. What we will include in this section, however, is a discussion of some of the most important patterns that we have seen from a review of the data.

I. PRE-RELEASE

A. BOSTON STATE PRE-RELEASE

Type of Release

A total of 68 men were admitted and released from the Boston State Pre-Release Center since its inception in November of 1973 and this study's cutoff date of July 1973. Nearly two-thirds (62%) of these individuals successfully completed the community release program, i.e. they were discharged or returned to the community on parole. A fourth of the residents were returned to the MCI from which they were transferred.

Employment Data

Forty (59%) of the 68 residents were employed in one or more jobs during their term of residence at Boston State. The large majority of these jobs were categorized at Boston State. The large majority of these jobs were categorized as semi-skilled positions. Twelve of the work releasees were successful in finding employment which utilized skills learned prior to incarceration. Two individuals obtained work utilizing skills acquired while incarcerated.

More than half of the 40 work release participants worked thirty-five days or more. The majority were released from the facility with full intentions of continuing their employment while on parole in the community. Four individuals were fired by their employer and a similar number terminated their employment as a result of transfer to their original committing institution.

Education

Eighteen of the residents of Boston State (26%) participated in educational release programs. Thirteen of these men attended academically oriented classes and one was receiving vocational training.

Final Living Unit Evaluation

The final living unit evaluations of the residents were on the whole every positive. Nearly two-thirds (63%) received average or better ratings. These findings simply reflect the overall success patterns of Boston State as program failures generally received the preponderant number of negative living unit evaluations.

B. SHIRLEY PRE-RELEASE CENTER

Type of Release

Shirley Pre-Release Center commenced operations in November of 1972. Between this time and July 1973 it admitted and released 59 men. More than half (54%) completed the program successfully and were released to the community on parole. The remainder were returned to MCI-Concord with the exception of one individual who absconded from the facility. The most frequently cited reason for return was "inability to adjust."

Over three-fourths of the Shirley residents were employed in one or more jobs. Jobs generally were classified as semi-skilled positions.

Gross earnings while on work release totalled more than three hundred dollars in over a third of the cases. Net income retained upon release was also substantial as over half (51%) of the releasees possessed more than one hundred dollars when returned to the community.

The jobs held by the residents prior to their release from the center were ended most frequently because the individual was returned to MCI-Concord or was paroled. In four cases the resident was paroled with the intention of continuing his employment while living in the community.

Education

Educational release programs were undertaken by eight individuals with at

four participating in academic programming and one receiving vocational training.

Final Living Unit Evaluation

The final living unit evaluations were very high with over eighty per cent receiving average or better ratings.

II. POST-RELEASE

A. BROOKE HOUSE

TYPE OF RELEASE

Of the 49 participants in the Brooke House program, over a fourth (28.6%) were terminated as successful completions and were continued on parole status. Nearly a third (32.7%), however, were discontinued from the program for failure to adjust. Another fourth (24.5%) absconded from the facility. Five individuals were terminated from the program because of an arrest for a new offense and two were transferred to another facility.

EMPLOYMENT DATA

Thirty-seven of the forty-nine residents at Brooke House held at least one job while at the facility, making a total of 55 jobs. Of these jobs, at least three utilized skills learned by the residents while incarcerated.

Termination of work assignments most often occurred as a result of the resident's own request (41.8%). Eleven individuals, however, were released from the program with the intent of continuing with the job. An additional five

men were fired from their jobs. The length of stay on the job was fairly short as less than a fourth (23.5%) worked more than a month.

Of the 55 jobs, 26 (47.3%) were classified as unskilled positions. Over a third, however, were in the semi-skilled category.

Gross earnings while in the program were more than \$300 for nearly half (45%) of the men. (The net income retained upon release was over \$100 for over a third of the residents (34.6%).

EDUCATION

Eight individuals at Brooke House participated in educational programs including six in academic programs and two in vocational training.

FINAL LIVING UNIT EVALUATION

Each resident, at the time of his termination, was rated in regard to his personal adjustment to the facility, as determined by his overall conduct and attitude. This evaluation, entitled the final living unit evaluation, was somewhat negative for the residents of Brooke House with 67.3% of the men having received either "below average" or "poor" ratings.

B. COOLIDGE HOUSE

During the first eighteen months of operation, 33 individuals were admitted and released from Coolidge House. Over a third (36.4%) were released to the community on parole. Approximately a fourth (24.2%) absconded from the facility and five men (15.2%) were arrested for a new offense. Four men were transferred to another facility and three failed to adjust to the program.

EMPLOYMENT DATA

Twenty-four of the 33 men held one or more jobs while residing at Coolidge House for a total of 40 jobs. Of these jobs, at least 3 were related to skills acquired while incarcerated. The large majority (42.5%) of jobs were terminated at the resident's request although seven men were paroled with expectations of continuing with the job. Job duration in three-fourths of the cases was a month or less.

The gross earnings of the men while in the Coolidge House were over \$100 for most (73.2%) of the residents. Nearly half (42.4%) of these men retained over \$100 at their time of release.

EDUCATION

Eight individuals at Coolidge House participated in some form of educational program with four in a vocational training program and another four men in academic oriented programs.

FINAL LIVING UNIT EVALUATION

Over half of the residents (54.6%) were given living unit evaluations that ranged from superior to average.

C. PROJECT OVERCOME

In total, 48 men were admitted and released from Project Overcome between February 1972 and July 1973. Of these individuals 13, or 27% of the total, were continued into the community on parole. Nearly half (45.8%) absconded from the facility and another fourth were terminated as a result of failure to adjust to the program.

EMPLOYMENT DATA

Nearly three-fourths (73%) of the men residing at Project Overcome were employed at one time during their stay at the facility. A total of 71 jobs were held by the 48 men. Over a third of the residents (37.5%) planned to continue to work at their job subsequent to release from the facility. Twenty of the jobs were terminated voluntarily and in 12 instances, the resident was fired.

Most (71.9%) of the jobs lasted thirty-five days or less. Generally they were of an unskilled or semi-skilled nature.

Over half (54.2%) of the residents' gross earnings during their stay totalled over \$300. Over a third retained more than \$200 upon release.

EDUCATION

Over a fourth of the residents were enrolled in some form of educational program. Of these men, twelve were enrolled in academic programs while two were pursuing vocational training.

FINAL LIVING UNIT EVALUATION

In general the residents adjustment to the resident community, as determined by his overall conduct and attitudes, was negative. Over half (54.2%) of the residents were given "poor" living unit adjustment ratings.

D. TEMPORARY HOUSING PROGRAM

TYPE OF RELEASE

The Temporary Housing Program is located at Brooke House but is a separately operated program. A total of 41 men were admitted and released from the Temporary Housing Program between the time of August, 1972 and July, 1973.

The large majority (78%) of these individuals were returned to the community on parole. The remainder absconded from the facility.

EMPLOYMENT DATA

Most of the participants of Temporary Housing held at least one job during their stay of residence. A total of 67 jobs were held by the 41 residents. Of these jobs, 12 were reported to utilize skills that residents learned while incarcerated in Massachusetts Correctional Institutions.

Over half (54%) of the 41 men were released from the Temporary Housing program with the intention of continuing with his employment. Seventeen jobs were terminated at the request of the resident. Because the average term of residence for Temporary Housing participants is much shorter than at the other halfway houses, the work release experience is relatively brief. In fact, none of the jobs lasted more than three weeks.

EDUCATION

Six individuals participated in academic educational programs and one was involved in vocational training.

FINAL LIVING UNIT EVALUATION

The final living unit evaluation was generally positive for the Temporary Housing participants with over half (56%) receiving average or better ratings.

E. PEACEFUL MOVEMENT COMMITTEE

The Peaceful Movement Committee, which began operation in January, 1973 accepted and released a total of 13 individuals between its opening date and July 31, 1973. Five individuals were successfully released on parole while four were terminated because of "failure to adjust." Two were arrested for a new crime and another two absconded from the facility.

Of these 13 individuals, only four are known to have been employed while at the facility. It is interesting to note that each of these four utilized skills previously learned with one having learned the skill while incarcerated. All 4 jobs were categorized as semi-skilled.

One of the employed residents planned to continue with his job following his release from the facility.

EDUCATION

Two of the 13 residents of the Peaceful Movement Committee participated in educational programs. Both were involved in academic programs with one also pursuing vocational training.

FINAL LIVING UNIT EVALUATION

The residents final living unit evaluations were relatively positive with over half receiving "average" to "above average" ratings.

F. ROXBURY COMMUNITY REHABILITATION CENTER

Roxbury Community Rehabilitation Center, which opened in April 1973 admitted and terminated only three offenders between that time and July 1973. One of these individuals was arrested for a new crime, another absconded and the third was terminated for failure to adjust.

None of the three participants were involved in either work release or educational programming although each was involved in some form of special activity.

The final living unit evaluation was average for one man and below average for the other two men.

PART V

COMMUNITY RELEASE FOLLOW-UP ANALYSIS

Part V of the report contains data on a 6-month follow-up for all residents who entered and terminated from either a pre or post release facility between the dates of November 1, 1972 and July 28, 1973. Follow-up data was collected from three sources: (1) a probation record report on each individual containing court appearances subsequent to release, (2) parole reports and (3) DOC central office files. The population at each CRS facility was divided into two distinct groups: successful program completions and residents who did not complete a full term of residency in the program. Since the residents of the pre-release centers who did not complete the program were returned to the institution from which they were transferred, recidivism data is inapplicable in these cases. However, since post-release clients are already on parole status, both residents who did and did not complete the CRS program are included in the follow-up analysis.

It should be stressed that this aspect of the study is a follow-up analysis for the first six months after release for each individual. Normally the DOC Research Unit collects recidivism data for at least a year subsequent to release. However, it was felt that it was important to the administrators of community-based correctional programs to receive as early feedback as possible. It would, however, be erroneous to compare the results of a six month follow-up with those past program or institutional analysis that were based on one year or two year follow-ups.

A second area of caution should also be emphasized. Since the interim report did not include a control sample, one must be very careful in the interpretation of these results in relation to traditional programming. The final CRS research design will, however, incorporate a control group for such comparative purposes.

Standard recidivism studies generally utilize two primary determinants of recidivism: parole revocation for technical violation and new arrest (includes parole revocation). In the table below, recidivism rates utilizing these criteria were calculated.

RESULTS

As stated previously, recidivism analyses for the participants of pre-release residents were conducted for program completers only in that all program failures were returned to their sending institution. However, data regarding the recidivism of the halfway house residents was presented for both program completers and program non-completers. As the above table indicates, there exists a substantial disparity between the recidivism rates for residents who successfully completed and post-release program and those who did not. For example, program completers at Brooke House had a zero recidivism rate whereas the rate for program "drop-outs" was 34%. The highest rate of recidivism for program completers was 17% at Coolidge House but the rate for non-completers was as high as 57%. The overall figures for the entire post-release system were 5% for the residents who completed the CRS program and 34% for non-completers.

It should be re-emphasized that these findings should be cautiously interpreted. The short follow-up period and the lack of a comparative control group preclude the formulation of definitive conclusions. However, as preliminary feedback, the results appear to be highly positive, thus lending tentative support to the concept of community release.

Post-release halfway house clients are already on parole and are thus not returned to their sending institution for program failure unless revoked by parole board.

In addition to the simple delineation of recidivism, more detailed follow-up data regarding post-program adjustment was gathered. A total of seven categories of post-program adjustment were utilized. These categories include:

- I. No Difficulty
- II. Parole Warning
- III. Parole Revoked, Technical Violation - Not Returned to Prison within 6-month follow-up.

- IV. New Arrest (and Parole Revoke) but Not Returned to Prison Within six months
- V. Parole Revoke, Technical Violation. Returned to Prison Within six months
- VI. New Arrest (and Parole Revoke). Returned to prison within 6 months.

The data regarding these seven categories is compiled in the tables on the following pages for the respective facilities.
