

Massachusetts General Laws and Associated NIBRS Codes

The following table was produced by the Division of Investigative Services of the Massachusetts State Police. It is being published in an effort to provide some degree of uniformity in the coding of criminal offenses.

The table should be used with caution. Although reasonable care was used in generating it, it is possible that some classification error were made. In addition, state statutes can change. In certain cases, care must be used in determining the proper NIBRS code. For example, although "A & B" is listed as "13A - Aggravated Assault", it might also be classified as a "13B - Simple Assault" depending on the nature of the injury sustaining by the victim or the intent of the attack.
