AN ACT RELATIVE TO THE DESIGNATION, BY THE CLERKS OF COURTS, OF CERTAIN ASSISTANT CLERKS AS CRIMINAL PROCEEDINGS CLERKS AND EQUITY PROCEEDINGS CLERKS.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Chapter 221, Section 6A is amended by striking the  
2 words “justices of the superior court” after the word “The” in line  
3 one, and inserting the words, “clerk of the courts for the county of  
4 Middlesex”; and further, by striking the words “for a term of three  
5 years from the date of such designation” after the word “designate”  
6 in line one, and inserting the words, “subject to removal by said  
7 clerk”.

1 SECTION 2. Chapter 221, Section 6B is amended by striking the  
2 words “justices of the superior court” after the word “The” in line  
3 one and inserting “clerk of the courts for the county of Essex”; and  
4 further by striking the words “for a term of three years from the date  
5 of such designation” after the word “designate” in line one, and  
6 inserting the words, “subject to removal by said clerk”.

1 SECTION 3. Chapter 221, Section 6C is amended by striking the  
2 words “justices of the superior court” after the word “The” in line  
3 one and inserting the words “clerk of courts for the county of  
4 Essex”; and further, by striking the words “for a term of three years  
5 from the date of such designation” after the word “designate” in line  
6 one and inserting the words “subject to removal by said clerk”.

1 SECTION 4. Chapter 221, Section 6D is amended by striking the  
2 words “by the court or” after the word “removal” in line two.

1 SECTION 5. Chapter 221, Section 6E is amended by striking the  
2 words “justices of the superior court” after the word “The” in line  
3 one, and inserting the words “clerk of courts for the county of  
4 Worcester”; and further, by striking the words “for a term of three  
5 years from the date of such designation” after the word “designate”  
6 in line one, and inserting the words “subject to removal by said  
7 clerk”.

1 SECTION 6. Chapter 221, Section 6F is amended by striking the  
2 words “justices of the superior court” after the word “The” in line  
3 one and inserting the words “clerk of courts for the county of  
4 Worcester”; and further, by striking the words “for a term of three  
5 years from the date of such designation” after the word “designate”  
6 in line one, and inserting the words, “subject to removal by said  
7 clerk”.

1 SECTION 7. Chapter 221, Section 6G is amended by striking the  
2 words “justices of the superior court” after the word “The” in line  
3 one and inserting the words “clerk of courts for the county of Mid-  
4 dlesex”; and further, by striking the words “for a term of three years  
5 from the date of such designation” after the word “designate” in line  
6 one, and inserting the words, “subject to removal by said clerk”.

1 SECTION 8. Chapter 221, Section 6I is amended by striking the  
2 words “justices of the superior court” after the word “The” in line  
3 one and inserting the words “clerk of courts for the county of Ply-  
4 mouth”; and further, by striking the words “for a term of three years  
5 from the date of such designation” after the word “designate” in line  
6 one, and inserting the words, “subject to removal by said clerk”.

1 SECTION 9. Chapter 221, Section 6J is amended by striking the  
2 words “justices of the superior court” after the word “The” in line  
3 one and inserting the words “clerk of courts for the county of Ply-  
4 mouth”; and further, by striking the words “for a term of three years  
5 from the date of such designation” after the word “designate” in line

4 pden”; and further, by striking the words “for a term of three years  
5 from the date of such designation” after the word “designate” in line  
6 one, and inserting the words, “subject to removal by said clerk”.

1 SECTION 12. Chapter 221, Section 6M is amended by striking  
2 the words “by the court or” after the word “removal” in line two.
