AN ACT EXTENDING CERTAIN CAPITAL SPENDING AUTHORIZATIONS.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. To provide for the continued availability of
 2 certain bond funded spending authorizations which otherwise
 3 would expire on June 30, 2007, or would expire upon the passage
 4 of this act as provided in section 2 of chapter 124 of the acts of
 5 2006, the balances of the following appropriation items and any
 6 allocations thereof are hereby extended through June 30, 2008, for
 7 the purposes of and subject to the conditions stated for these items
 8 in the original authorizations and any amendments to those autho-
 9 rizations
