AN ACT CHANGING THE NAME OF THE MASSACHUSETTS COLLEGE OF ART.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. The name of the Massachusetts College of Art is
2 hereby changed to the Massachusetts College of Art and Design.

1 SECTION 2. Paragraph (a) of section 4 of chapter 15A of the
2 General Laws, as appearing in the 2004 Official Edition, is hereby
3 amended by striking out, in line 54, the words “Massachusetts
4 College of Art” and inserting in place thereof the following
5 words:— Massachusetts College of Art and Design.

1 SECTION 3. The first paragraph of section 5 of chapter 15A of
2 the General Laws, as so appearing, is hereby amended by striking
3 out, in line 6, the words “Massachusetts College of Art” and
4 inserting in place thereof the following words:— Massachusetts
5 College of Art and Design.

1 SECTION 4. The first paragraph of section 1 of chapter 73 of
2 the General Laws, as appearing in the 2004 Official Edition, is
3 hereby amended by striking out, in lines 15 and 22 the words
4 “Massachusetts College of Art” and inserting in place thereof the
5 following words:— Massachusetts College of Art and Design.

1 SECTION 5. Section 1A of said chapter 73, as so appearing, is
2 hereby amended by striking out, in lines 2 and 3, inclusive, the
3 words “Massachusetts College of Art” and inserting in place
4 thereof the following words:— Massachusetts College of Art and
5 Design.

1 SECTION 6. Section 1B of said chapter 73, as so appearing, is
2 hereby amended by striking out, in lines 2 and 3, inclusive, the
3 words “Massachusetts College of Art” and inserting in place
4 thereof the following words:— Massachusetts College of Art and
5 Design.

1 SECTION 7. Section 4B of said chapter 73, as so appearing, is
2 hereby amended by striking out, in line 2, the words “Massachu-
3 setts College of Art” and inserting in place thereof the following
4 words:— Massachusetts College of Art and Design.

1 SECTION 8. Section 8 of said chapter 73, as so appearing, is
2 hereby amended by striking out, in line 3, the words “Massachu-
3 setts College of Art” and inserting in place thereof the following
4 words:— Massachusetts College of Art and Design.

1 SECTION 9. Section 10 of said chapter 73, as so appearing, is
2 hereby amended by striking out, in line 7, the words “Massachu-
3 setts College of Art” and inserting in place thereof the following
4 words:— Massachusetts College of Art and Design.

1 SECTION 10. Section 19 of said chapter 73, as so appearing, is
2 hereby amended by striking out, in lines 5 and 6, inclusive, the
3 words “Massachusetts College of Art” and inserting in place
4 thereof the following words:— Massachusetts College of Art and
5 Design.

1 SECTION 11. Clause (h) of section 1 chapter 703 of the Acts
2 of 1963, as most recently amended by section 3 of chapter 200 of
3 the Acts of 1985, is hereby amended by striking out, in lines 2
4 through 3, inclusive, the words “the Massachusetts College of Art,
5 the Massachusetts Maritime Academy, North Adams State
6 College” and inserting in place thereof the following words:— the
7 Massachusetts College of Art and Design, the Massachusetts Mar-
8 itime Academy, the Massachusetts College of Liberal Arts.
