AN ACT INCREASING PENALTIES FOR VIOLATION OF THE CONFLICT OF INTEREST LAW

*Be it enacted by the Senate and House of Representatives in General Court assembled,
And by the authority of the same, as follows:*

1 SECTION 1. Section 2 of Chapter 268A of the General Laws, as appearing in the 2004 Official
2 Edition, is hereby amended by striking out in line 46 the words “five thousand dollars” and inserting in
3 place thereof the following figure:- \$25,000

4 SECTION 2. Section 3 of said chapter 268A, as so appearing, is hereby amended by striking out in
5 lines 30 and 31 the words “three thousand dollars” and inserting in place thereof the following figure:-
6 \$10,000

7 SECTION 3. Section 4 of said chapter 268A, as so appearing, is hereby amended by striking out in
8 line 17 the words “three thousand dollars” and inserting in place thereof the following figure:- \$10,000

9 SECTION 4. Section 5 of said chapter 268A, as so appearing, is hereby amended by striking out in
10 line 41 the words “three thousand dollars” and inserting in place thereof the following figure:- \$10,000

11 SECTION 5. Section 6 of said chapter 268A, as so appearing, is hereby amended by striking out in
12 lines 7 and 8 the words “three thousand dollars” and inserting in place thereof the following figure:-

14 SECTION 6. Section 7 of said chapter 268A, as so appearing , is hereby amended by striking out in
15 line 5 the words “three thousand dollars” and inserting in place thereof the following figure:- \$10,000

17 line 17 the words “five thousand dollars” and inserting in place thereof the following figure:- \$10,000

27 lines 7 and 8 the words “three thousand dollars” and inserting in place thereof the following figure:-

32 the word “inclusive” in line 3 the following phrase:- and any violation of section 23,

49 SECTION 22. Section 21B of said chapter 268A, as so appearing, is hereby amended by striking out
50 in line 6 the words “five hundred dollars” and inserting in place thereof the following figure:- \$2,000

51 SECTION 23. Section 4 of said chapter 268B, as so appearing, is hereby amended by striking out in
52 line 73 the words “two thousand dollars” and inserting in place thereof the following figure:- \$10,000
