

Mr. Hill of Ipswich moves to amend House bill 3770 in line 75, by striking out “precincts 2 and 3 of the town of Boxford” and inserting in place thereof “the town of Rowley”;

And further, in line 80, by striking out “Rowley” and inserting in place thereof “precincts 1 and 3 in the town of Boxford”;

And further, in line 112, by striking out “precinct 1 of the town of Boxford” and inserting in place thereof “precinct 2 of the town of Boxford”.

Mr. Brownsberger of Belmont and Mr. Garballey of Arlington move that the bill, H3770, be amended as follows:

Twenty-third Middlesex. - In line 218 delete the numeral 2 and insert the numeral 14;

Twenty-fourth Middlesex. - In line 221 delete the numeral 14 and insert the numeral 2.

Mr. Peterson of Grafton and Mr. Beaton of Shrewsbury move to amend House Bill 3770, in line 172 by striking "precincts 1 and 3 of the town of Westborough" and inserting in place there of "precinct 1 and 2 in the town of Southborough";

and precincts 1 and 3 of the town of Westborough, both” and inserting in place thereof “precinct
1 of the town of Southborough,”;

and further, in line 181, by inserting after the word “Middlesex;” the following: “precincts 2 and
3, of”;

and further, in line 181, by striking “precinct 2,” and inserting in place thereof “precincts 2 and
3,”;

and further, in line 194, by striking “city” and inserting in place thereof “town”;

and further, in lines 194 and 195, by striking “ward 1, precinct 2 of ward 2, and precinct 1 of
ward 7 in the city of Marlborough,” and inserting in place thereof “the town of Maynard,”;

and further, in line 399, by striking "Berlin,";

and further, in lines 399 and 400, by striking “Lancaster, precincts 2 and 4 of the town of
Northborough, and” and inserting in place thereof “Northborough,”;

and further, in line 400, by inserting after the word “Sterling,” the following: “and precinct 1, of
the town of Westborough,”.

Mr. Levy of Marlborough moves to amend House Bill 3770, in line 171, by striking "precincts 1 and" and inserting in place thereof "the town of Berlin, and precinct";
and further, in line 172, by striking "both" and inserting in place thereof "all";
and further, in line 399, by striking "Berlin"; and inserting, in line 399, after the word "precincts" the following: "1, ".

Ms. Dykema of Holliston moves to amend House Bill 3770, in line 170, by striking ", ward 6, and precinct 2 of ward 7" and inserting in place thereof "and ward 6";

and further, in line 172, by striking "1 and 3" and inserting in place thereof "2, 3 and 5";

and further, in line 176, by striking "4" in inserting in place thereof "3";

and further, in line 180, by striking "the towns of Holliston and Hopkinton, both" and inserting in place thereof "precinct 4 in the city of Framingham, and the towns of Holliston and Hopkinton, all";

and further, in line 181, by striking "the town of Southborough, and precinct 2 of Westborough, all" and inserting in place thereof "and the town of Southborough";

and further, in line 194, by striking "precinct 3 in the city of Framingham,"

and further, in line 195, by striking "precinct 1 of";

and further, in line 397, by striking "4 and 5" and inserting in place thereof "1 and 4".

Mr. Durant of Spencer moves to amend House Bill 3770, in line 387, by inserting after the word "Dudley, " the following "the town of East Brookfield, "; and further, in line 384, by striking "East Brookfield"

Mr. Sullivan of Fall River moves to amend House Bill no. 3770 in line no. 49 by striking the words precinct C of ward 6 and adding the words precinct C of ward 4
