Monday, March 16, 2009.

Met according to adjournment, at eleven o'clock A.M., in an Informal Session, with Mr. Petrolati of Ludlow in the Chair (having been appointed by the Speaker, under authority of Rule 5, to perform the duties of the Chair).

Prayer was offered by the Reverend Robert F. Quinn, Chaplain of the House, as follows:
