Tuesday, April 21, 2009.

Met according to adjournment, at eleven o'clock A.M., in an Informal Session, with Mr. Donato of Medford in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair.

Message from the Governor.

Clean energy.

A message from His Excellency the Governor recommending legislation relative to clean energy (House, No. 4072) was filed in the Office of the Clerk on Monday, April 6.

The message was read; and it was referred, under Rule 30, with the accompanying draft of a bill, to the committee on Economic Development and Emerging Technologies. Sent to the Senate for concurrence.

Resolutions.

The following resolutions (filed with the Clerk) were referred, under Rule 85, to the committee on Rules:

Resolutions (filed by Mr. Bradley of Hingham) recognizing the fourteenth of May as Tower Day, in recognition of John Tower (1), in the town of Hingham;

Resolutions (filed by Mr. Guyer of Dalton) recognizing Lights Out, Green In Pledge;

Henry L. Robichaud.

Resolutions (filed by Mr. Rice of Gardner) recognizing Henry L. Robichaud for fifty years of service to the Gardner Franco-American Federal Credit Union; and

Edward M. Merrick, Jr.

Resolutions (filed by Mr. Ross of Wrentham) congratulating Chief Edward M. Merrick, Jr., on the occasion of his retirement;

Mr. Binienda of Worcester, for the committee on Rules, reported, in each instance, that the resolutions ought to be adopted. Under suspension of the Rules, in each instance, on motion of Mr. Kafka of Stoughton, the resolutions (reported by the committee on Bills in the Third Reading to be correctly drawn) were considered forthwith; and they were adopted.

Petition.

Mr. Aguiar of New Bedford presented a petition (subject to Joint Rule 12) of Kevin Aguiar for legislation to establish a sick leave bank for Jennifer Moniz, an employee of the Registry of Motor Vehicles; and the same was referred, under Rule 24, to the committee on Rules.

By Mr. Binienda of Worcester, for the committee on Rules and the committees on Rules of the two branches, acting concurrently, the reported recommending that Joint Rule 12 be suspended. Under suspension of the rules, on motion of Ms. Provost of Somerville, the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on Public Service. Sent to the Senate for concurrence.

Papers from the Senate.

The Senate Bill relative to making certain changes in the retirement system of the Commonwealth (Senate, No. 2026, amended) came from the Senate with the endorsement that said branch had non-concurred with the House in its amendment (striking out all after the enacting clause and inserting in place thereof the text contained in House document numbered 4060).

Retirement system.

The bill bore the further endorsement that the Senate had asked for a committee of conference; and that Senators Panagiotakos, McGee and Brown had been appointed as the committee on the part of the Senate.

The House then insisted on its amendment; and, on motion of Mr. Spellane of Worcester, concurred with the Senate in the appointment of a committee of conference. Representatives Spellane, Rodrigues of Westport and Smola of Palmer were appointed the committee on the part of the House. Sent to the Senate to be noted.

A Bill to establish a supplementary tax rate in the town of Rockland (printed as House, No. 4050) (on a petition) [Local Approval Received], passed to be engrossed by the Senate, was read; and it was referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

A report of the committee on Consumer Protection and Professional Licensure, asking to be discharged from further consideration of the petition (accompanied by bill, Senate, No. 174) of Michael W. Morrissey for legislation to establish the Massachusetts Gaming Control Act, and recommending that the same be referred to the committee on Economic Development and Emerging Technologies,—accepted by the Senate, was considered forthwith, under Rule 42; and it was accepted, in concurrence.
