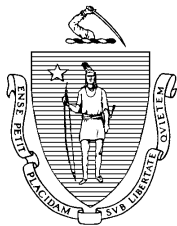

Thursday, April 23, 2009.

Met according to adjournment, at eleven o'clock A.M., in an Informal Session, with Mr. Donato of Medford in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair.

Charlestown
Navy Yard.

A petition of Eugene L. O'Flaherty (accompanied by bill, House, No. 4075) for legislation to extend the harbor lines for the building of certain navigable waters of the Charlestown Navy Yard located in the city of Boston (having been returned by the State Secretary, under the provisions of Chapter 3 of the General Laws with memoranda relative thereto) was referred to the committee on Environment, Natural Resources and Agriculture. Sent to the Senate for concurrence.

Home of the
Brave, Inc.

A petition of Garrett J. Bradley and other members of the General Court (accompanied by bill, House, No. 624) for legislation to authorize the board of trustees of The Home of the Brave, Inc., to operate certain public homes for veterans (having been returned by the State Secretary, under the provisions of Chapter 3 of the General Laws with a statement relative thereto) was referred to the committee on Housing. Sent to the Senate for concurrence.

Report of a Committee.

Arlington,—
Redevelopment
Board.

By Mr. Kafka of Stoughton, for the committee on Steering, Policy and Scheduling, that the Bill establishing the Arlington Redevelopment Board as the Board of Survey (House, No. 3471) be scheduled for consideration by the House. Under suspension of Rule 7A, on motion of the same member, the bill was read a second time forthwith; and it was ordered to a third reading.

Emergency Measure.

The engrossed Bill relative establishing a sick leave bank for Michael P. Harrington, an employee of the Department of Conservation and Recreation (see House, No. 2579) having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 8 to 0. Sent to the Senate for concurrence.
