

### JOURNAL OF THE HOUSE.

Wednesday, May 27, 2015.

Met according to adjournment, at eleven o'clock A.M., with Mr. Donato of Medford in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

Pledge of allegiance.

At the request of the Chair (Mr. Donato), the members, guests and employees joined with him in reciting the pledge of allegiance to the flag.

At the beginning of the session, the Chair (Mr. Donato of Medford) introduced, seated in the House Chamber, students from Arlington High School, the guests of Mr. Garballey of Arlington; and students from the Riverdale School in Dedham, the guests of Mr. McMurtry of Dedham. The students and chaperones from both schools then participated in leading the House in the pledge of allegiance to the flag.

#### Message from the Governor.

Essex,—town meeting.

A message from His Excellency the Governor (under Section 8 of Article LXXXIX of the Amendments to the Constitution) recommending legislation relative to validating the actions taken at an annual town meeting and election in the town of Essex (House, No. 3559), was filed in the office of the Clerk on Friday, May 22.

The message was read; and it was referred, under Rule 30, with the accompanying draft of a bill, to the committee on Election Laws. Sent to the Senate for concurrence.

#### Paper from the Senate.

The House Bill making appropriations for the fiscal year 2016 for the maintenance of the departments, boards, commissions, institutions and certain activities of the Commonwealth, for interest, sinking fund and serial bond requirements and for certain permanent improvements (House, No. 3401), came from the Senate passed to be engrossed, in concurrence, with an amendment striking out all after the enacting clause and inserting in place thereof the text contained in Senate document numbered 1930.

General Appropriation Bill.

Under suspension of the rules, on motion of Mr. Dempsey of Haverhill, the amendment was considered forthwith. The House then non-concurred with the Senate in its amendment; and, on further motion of the same member, asked for a committee of conference on the disagreeing votes of the two branches. Messrs. Dempsey, Kulik of Worthington and Smola of Warren were appointed the committee on the part of the House. Sent to the Senate to be joined.

Committee of conference.

Subsequently notice was received from the Senate that said branch had insisted on its amendment, concurred with the House in the appointment of a committee of conference; and that Senators Spilka, DiDomenico and deMacedo had been joined as the committee on the part of the Senate.
