JOURNAL OF THE HOUSE.

Wednesday, June 24, 2009.

Met according to adjournment at eleven o'clock A.M., in an Informal Session, with Mr. Donato of Medford in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

Pledge of allegiance.

At the request of the Chair (Mr. Donato), the members, guests and employees joined with him in reciting the pledge of allegiance to the flag.

Guests of the House.

Bancroft School.

The Chair (Mr. Donato) then declared a brief recess and introduced teachers and students from the Bancroft School in Andover who were seated in the House Chamber. They were the guests of Representative L'Italien of Andover.

Dupuis Family of Upton.

Mr. Donato then introduced the Dupuis Family from the town of Upton, including father Kevin, mother Christine and sons Matthew, Peter and Charlie. They were the guests of Representatives Peterson of Grafton and Polito of Shrewsbury.

Salem,—liquor license.

Petitions were referred, in concurrence, as follows:

By Mr. Kocot of Northampton, for the committee of conference on the disagreeing votes of the two branches, with reference to the Senate amendment (striking out all after the enacting clause and inserting in place thereof the text contained in Senate document numbered 2052) of the House Bill to improve the laws relating to campaign finance, ethics and lobbying (House, No. 3856), recommending passage of a bill with the same title (House, No. 4133). Referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

Mr. Kafka of Sharon, for the committee on Steering, Policy and Scheduling then reported that the matter be scheduled for consideration by the House; and, under said rule, it was placed in the Orders of the Day for the next sitting, the question being on acceptance.
