Pending the question on passing the bill to be engrossed, Mr. Peterson of Grafton and other members of the House moved to amend it by inserting after section 1 the following section:

“SECTION 1A. The first paragraph of section 5 of chapter 660 of the acts of 1987 is hereby amended by striking out the second sentence and inserting in place thereof the following sentence:— The conveyance shall be in accordance with such terms and conditions as the deputy commissioner shall prescribe, including, but not limited to, a preservation restriction in perpetuity with the Massachusetts historical commission.”
