Thursday, July 9, 2009.

Met according to adjournment at eleven o'clock A.M., in an Informal Session, with Donato of Medford in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

A Bill relative to the Leino Park Water District (Senate, No. 2068) (on a petition), passed to be engrossed by the Senate, was read, and it was referred, under Rule 7A, to the committee on Steering, Policy and Scheduling. Leino Park

*Emergency Measure.*

The engrossed Bill establishing a sick leave bank for Margaret Freddie Purcell, an employee of the Department of Developmental Services (see House, No. 4080, amended), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble. A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 4 to 0. Sent to the Senate for concurrence.

Subsequently, the Senate having concurred in adoption of the emergency preamble, the bill (which originated in the House) was passed to be enacted; and it was signed by the acting Speaker and Senate to the Senate. Bill
