Thursday, July 16, 2009.

Met according to adjournment at eleven o'clock A.M., in an Informal Session, with Donato of Medford in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

Emergency Measure.

The engrossed Bill establishing a sick leave bank for Tanya M. Dubois, an employee of the Trial Court (see House, No. 1683, amended), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.
